145 Crash Description/Narrative

V1 was traveling north on Manchester Avenue and was making a left turn onto Western Boulevard when it collided with V2 which was traveling south on Manchester Avenue.

The driver of V1 stated V2 came out of nowhere and didn't see it until it was too late.

The driver of V2 stated she was traveling south on Manchester Avenue when V1 suddenly made a left turn in front of her.

School crossing guards at the intersection indicated the light for Manchester Avenue was green for both directions prior to the crash.

The driver of V1 was found to be at fault for driver inattention.

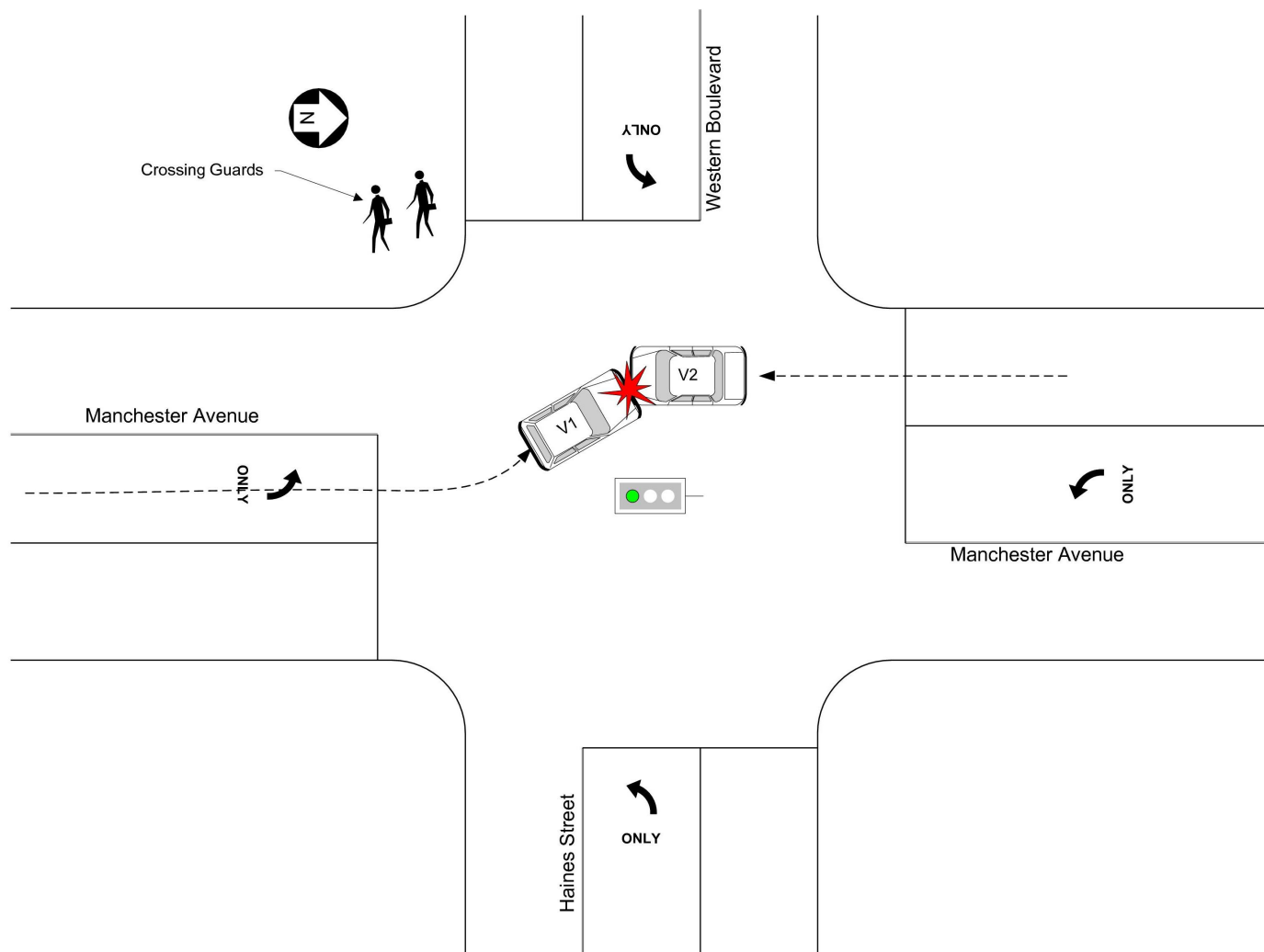
