Motor Vehicle Crash Diagram

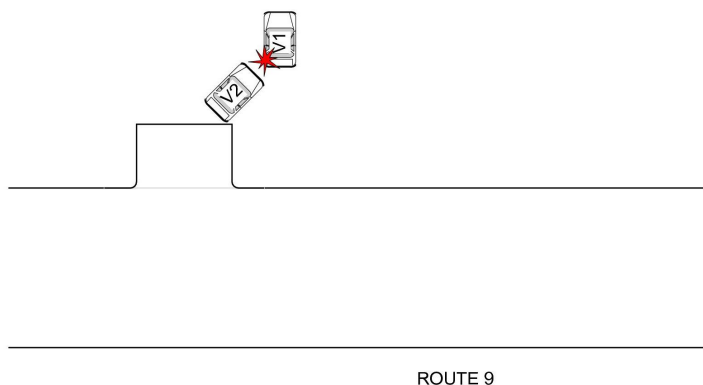
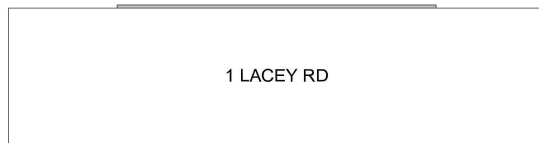
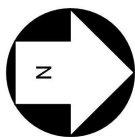
