145 Crash Description/Narrative

D1 was attempting to park in a designated parking space at the Lanoka Harbor Post Office (402 Route 9 North in Lanoka Harbor) when she inadvertently placed her foot on the gas pedal. V1 accelerated forward, striking a concrete parking curb, building support column, and the south wall of the Post Office exterior.

A witness stated she observed V1 attempting to park, prior to V1 striking a parking curb, building support column, and building.

Further police investigation revealed that driver inattention, committed by D1, was the main contributing factor leading to the crash.

Motor Vehicle Crash Diagram

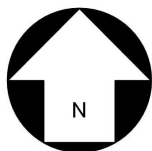

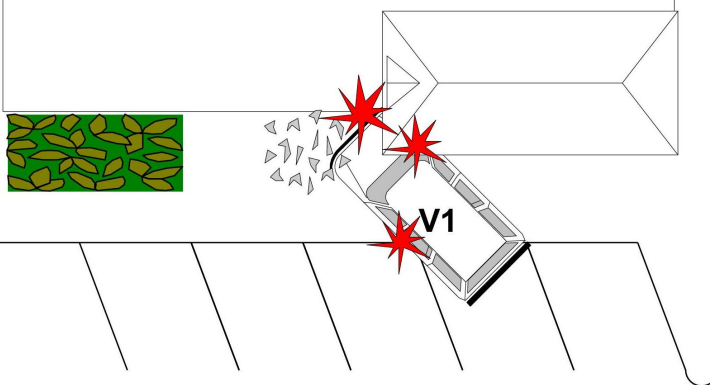
