145 Crash Description/Narrative

D2 stated she was traveling north on Route 9 and was slowing in traffic when she was struck from the rear by V1. D2 stated the traffic light was red and vehicles in front of her were stopping. D2 stated she saw V1 traveling fast behind her and she pulled to the right shoulder to attempt to avoid the collision. D2 stated she was then struck from the rear by V1. P6 in V2 complained of back pain from after the collision and Squad 26 transported her to SOMC. V2 had minor damage from the collision but was safe to operate.

D1 stated he was traveling north on Route 9 when V2 stopped short in traffic. D1 stated he pulled to the left to attempt to avoid the collision. D1 stated he struck the rear of V2.

Motor Vehicle Crash Diagram

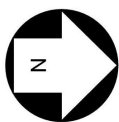
