

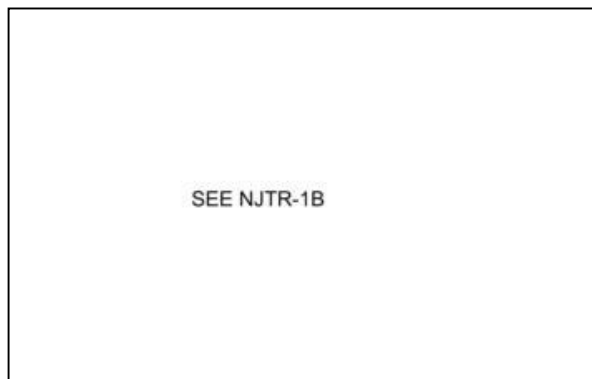

145 Crash Description/Narrative

V1 was attempting to execute a left turn onto Clearwater Drive, from the southbound lane of Route 9 in Forked River, when V1 was struck by V2 (Motorcycle). V2 was traveling north on Route 9, without a headlight activated as required. The crash resulted in D2 being ejected from V2, and caused disabling damage to both vehicles.

D1 stated she attempted to execute the turn, as it was dark, and did not see V2 as it was traveling without a headlight activated as required.

A witness stated that he, observed V2 traveling north through the intersection of Route 9 and Beach Boulevard without a headlight activated as required, stating he also almost struck V2.

Further Police Investigation revealed that D2 was operating a motorcycle unlicensed, as well as traveling without headlights activated as required. These violations were determined to be the main contributing factor leading to the crash.

****BOX 119B:** D2 was operating without a motorcycle endorsement on his license, as well as without a learners permit.

****BOX 136:** Summons issued to D2 pursuant to 39:3-10, Unlicensed Driver.

****BOX 137:** Summons issued to D2 pursuant to 39:3-47A, Headlights Required.

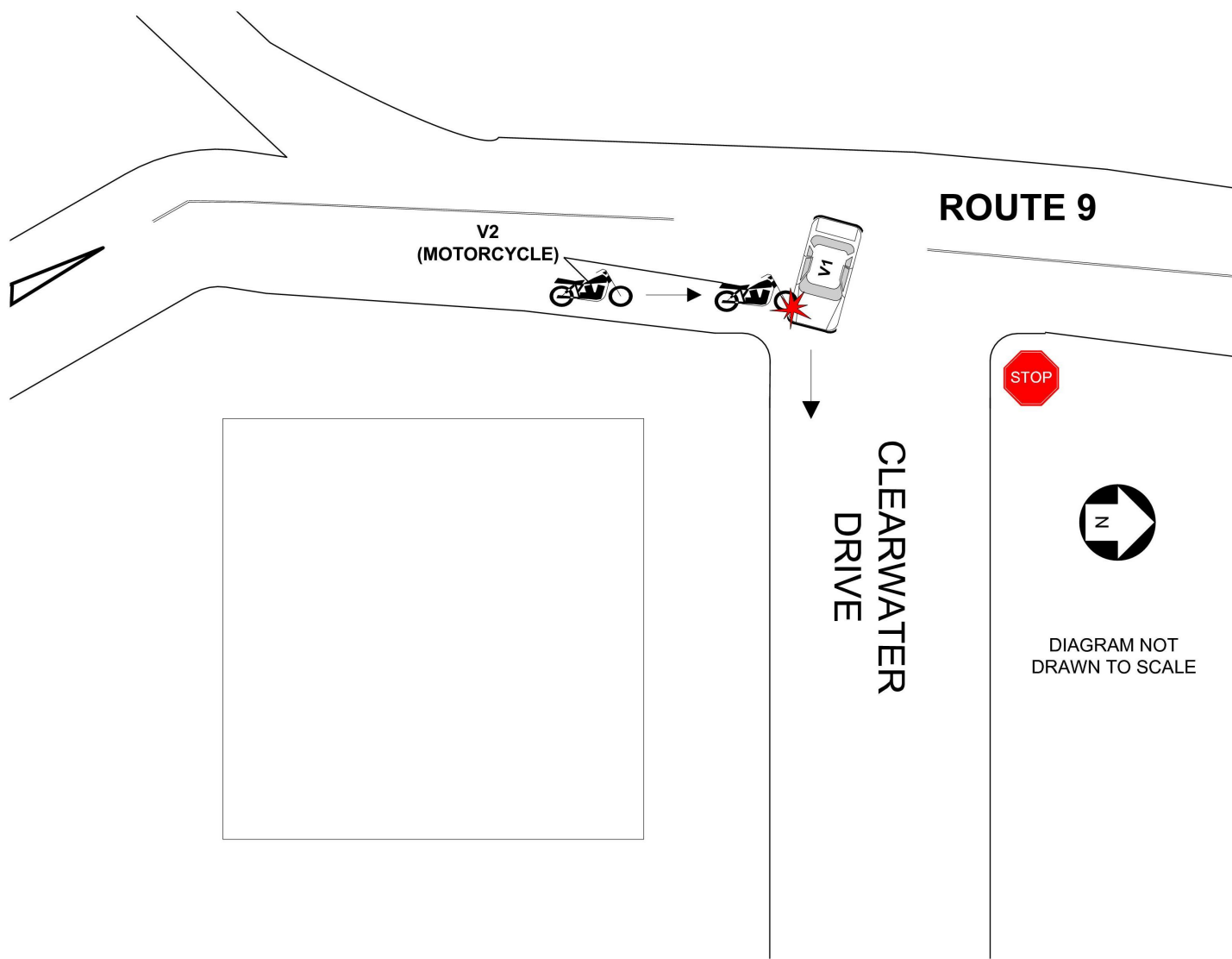
