DRIVER OF V1 STATED HE WAS TRAVELING NORTH ON MANCHESTER AVE WHEN V2 PULLED OUT IN FRONT OF HIM FROM ADAMS ST. DRIVER OF V2 STATED SHE WAS AT THE STOP SIGN LOCATED ON ADAMS ST ATTEMPTING TO MAKE A LEFT HAND TURN ONTO MANCHESTER AVE AND PULLED IN FRONT OF V1. DRIVER OF V2 STATED THAT THERE WAS A LARGE TRUCK PULLED ON THE SHOULDER OF MANCHESTER AVE OBSTRUCTING HER VIEW.

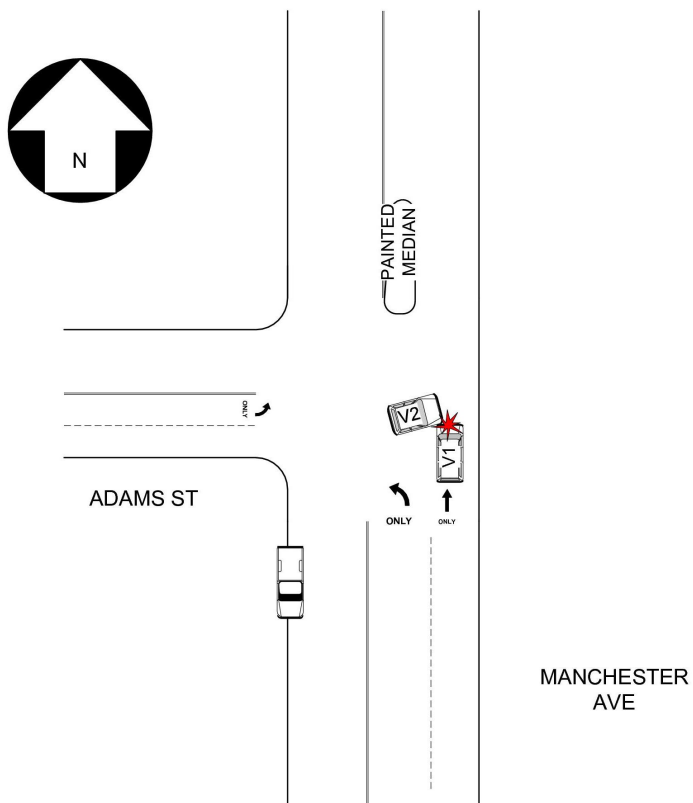
