Motor Vehicle Crash Diagram

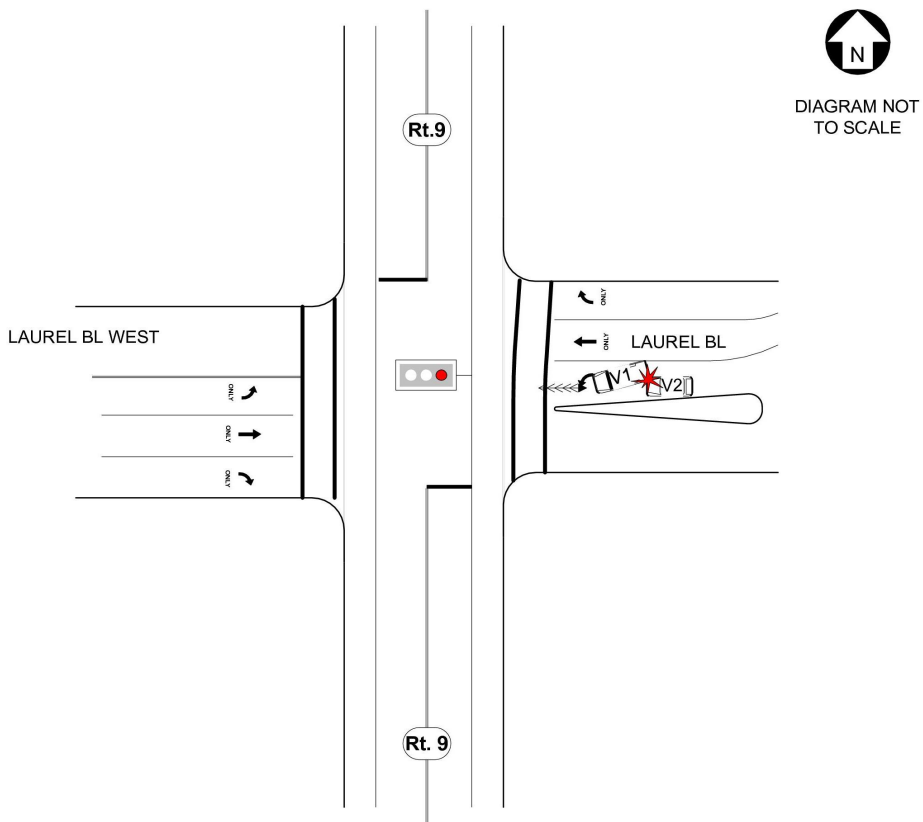
