If your office does not possess these records, I am instead requesting other reports of all forfeitures by type for fiscal years 2014 to 2019, specifically documents that include the total amount of assets forfeited in Monmouth County Prosecutor's Office under New Jersey state law for those years. I am also requesting line item expenditures from forfeiture proceed funds for the fiscal years 2014 to 2019 and totals for each category of expenditures from forfeiture proceed funds for fiscal years 2014 to 2019. 1. Reports on collisions that occurred during police vehicle pursuits which were made available to the county prosecutor since 1/1/2009, pursuant to the New Jersey Attorney General's policy on police vehicle pursuits.

For background, the New Jersey Attorney General's policy on police vehicle pursuits states: "Every law enforcement agency shall conduct an investigation when one of its vehicles collides with another vehicle or any other object during the course of a pursuit. The investigation shall determine whether the collision could have been prevented. A copy of the report shall be made available to the county prosecutor. In every case where the collision could have been prevented, the report shall set forth the actions taken by the agency to address the cause or causes of the collision (e.g. remedial training, revision of department policy, disciplinary action, etc.)."

We ask that you release records as each becomes available for public disclosure. Please do not temporarily withhold one record that has been approved for public disclosure because you require additional time to review others.

We ask that these records be provided electronically and sent by e-mail (aford3@gannettnj.com) or through a cloud-based file storage system such as DropBox. An upload link can be provided.

We respectfully request that any fees be waived since the records will be used for newsgathering purposes and ultimately released to the public in some form to shed light on the operations of government. If the agency expects to require payment for copies, record location or other elements of the request, please provide a fee estimate before proceeding so that I may weigh the cost and consider my options.

If you claim any portion of the above public records are exempt from disclosure under the law, please provide a Vaughn index identifying which records exist, which portion or portions you claim are exempt and the legal provisions you contend apply, and release the remainder of such records, redacting only the portion or portions you claim are exempt.

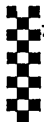

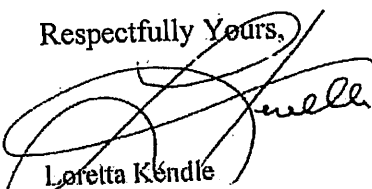

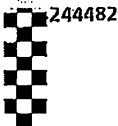
