Vehicle 1 was traveling South on New Jersey Avenue. Vehicle 2 was traveling North on New Jersey Avenue. V1 then attempted to make a left hand turn onto 100 East 26th Avenue, failing to yield to V2 which was also coming through the intersection still traveling North.
