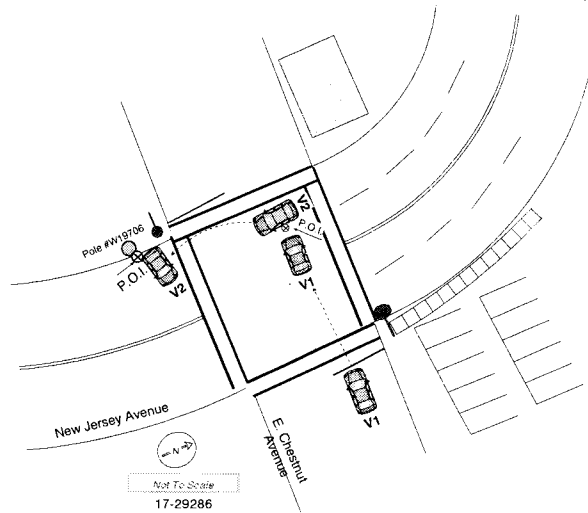

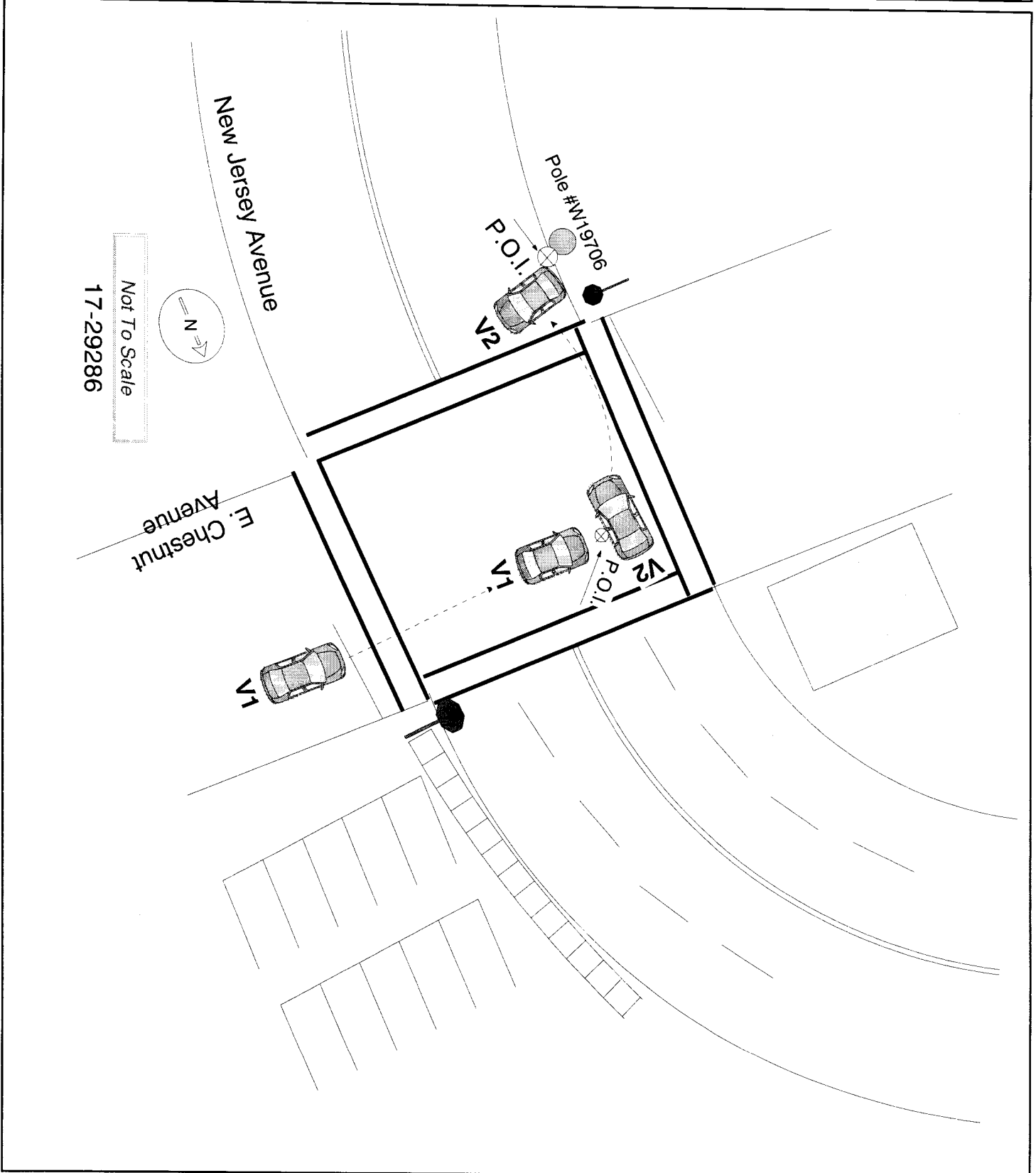
145. Crash Description/Narrative

V1 struck V2 as V2 was traveling south bound on New Jersey Avenue. This collision caused V2 to strike utility pole #W19706 V1 had a posted Stop sign which was located at the North East Corner of Chestnut Avenue V1 suffered major front end damage causing the vehicle to be towed to Bob's Auto Body V2 suffered initial damage to the entire driver side of the vehicle as well as the rear passenger side quarter panel after striking the utility pole. V2 was also towed by Bob's Auto Body The driver of V1 was transported to Cape Regional Medical Center regarding a possible neck injury. V2 had contusions to her left elbow area however refused medical assistance.
