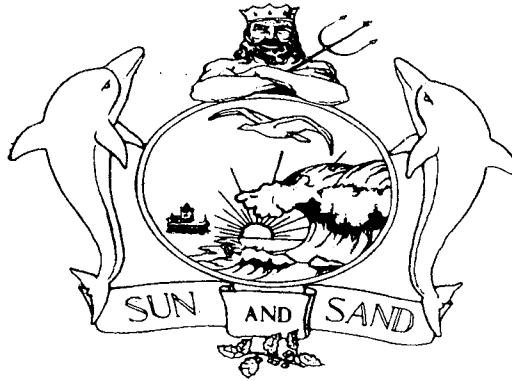

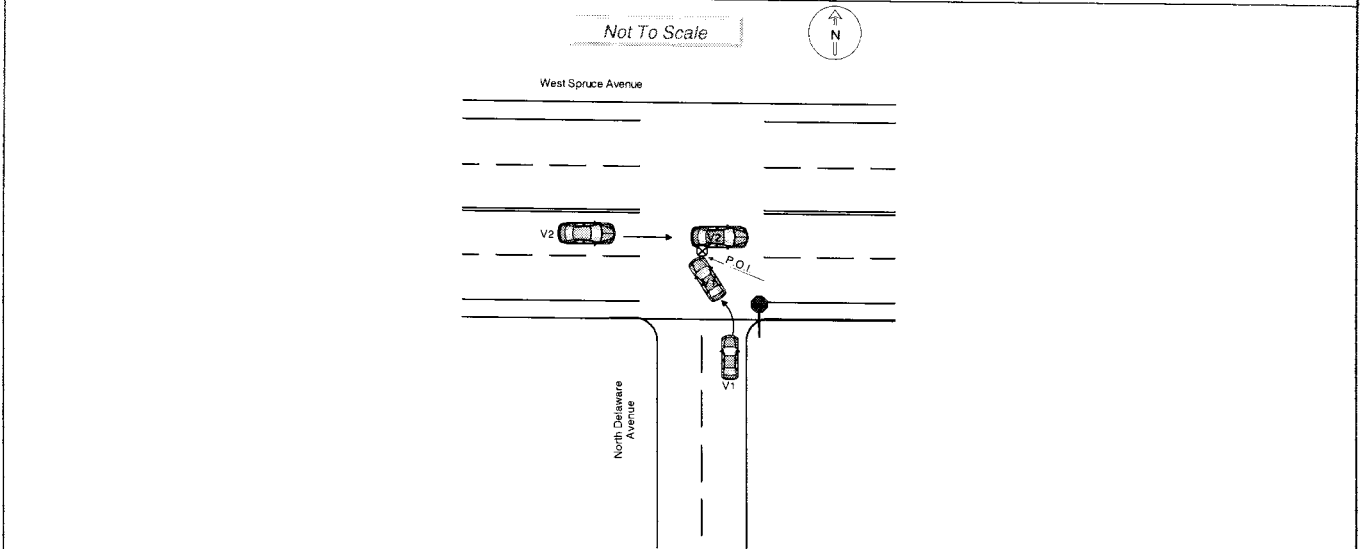

145. Crash Description/Narrative

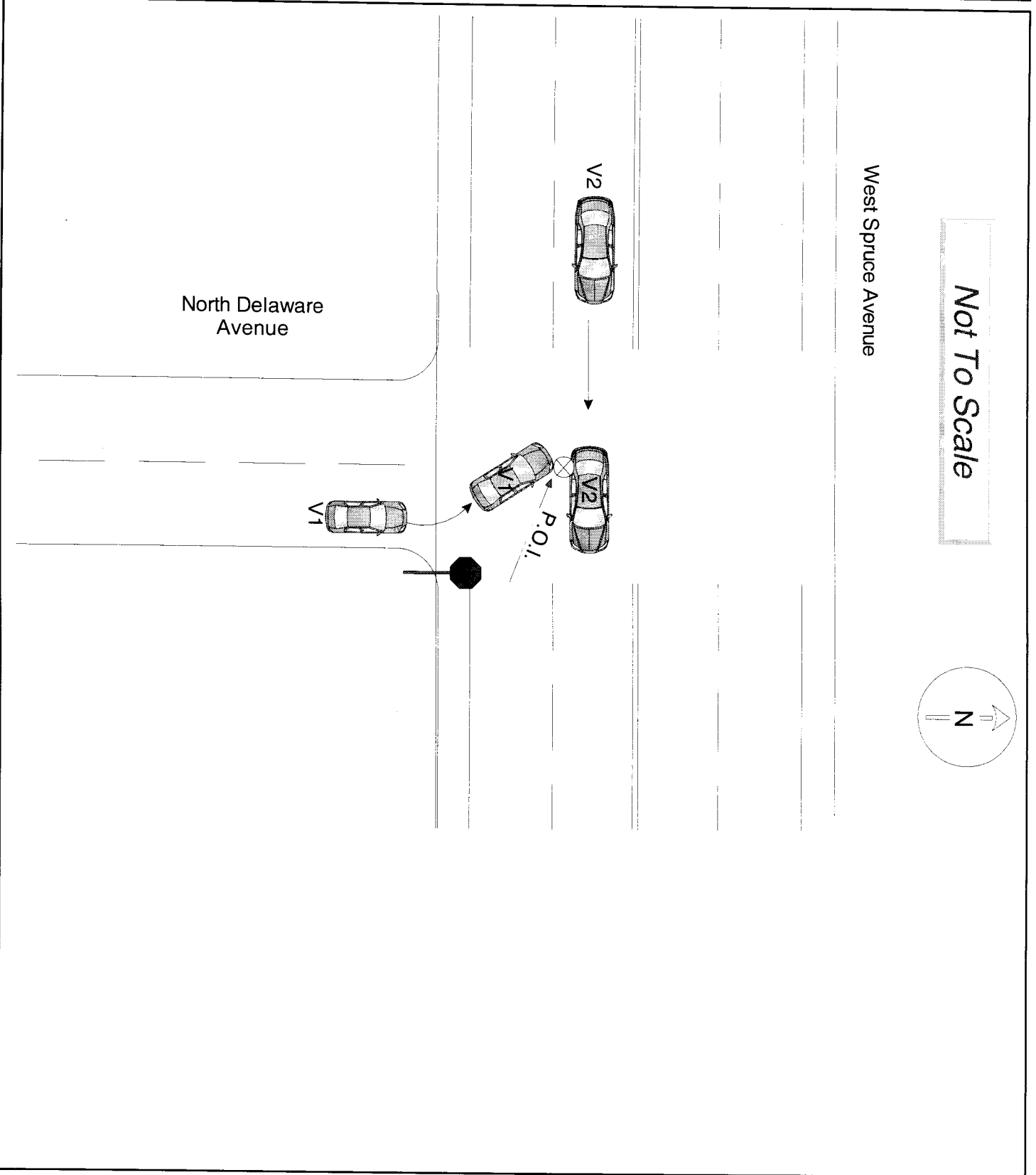
V1 was stopped at a stop sign at the intersection of Delaware Avenue and Spruce Avenue. V2 was traveling Eastbound on Spruce Avenue. V1 proceeded to make a left turn onto Spruce Avenue. V1 did not see V2 traveling and struck the passenger rear wheel of V2. V1 received damage to the passenger side of the front bumper. V2 received damage to the passenger side rear wheel disabling the vehicle. V2 was towed away from the scene to Bob's Auto Body in Wildwood.

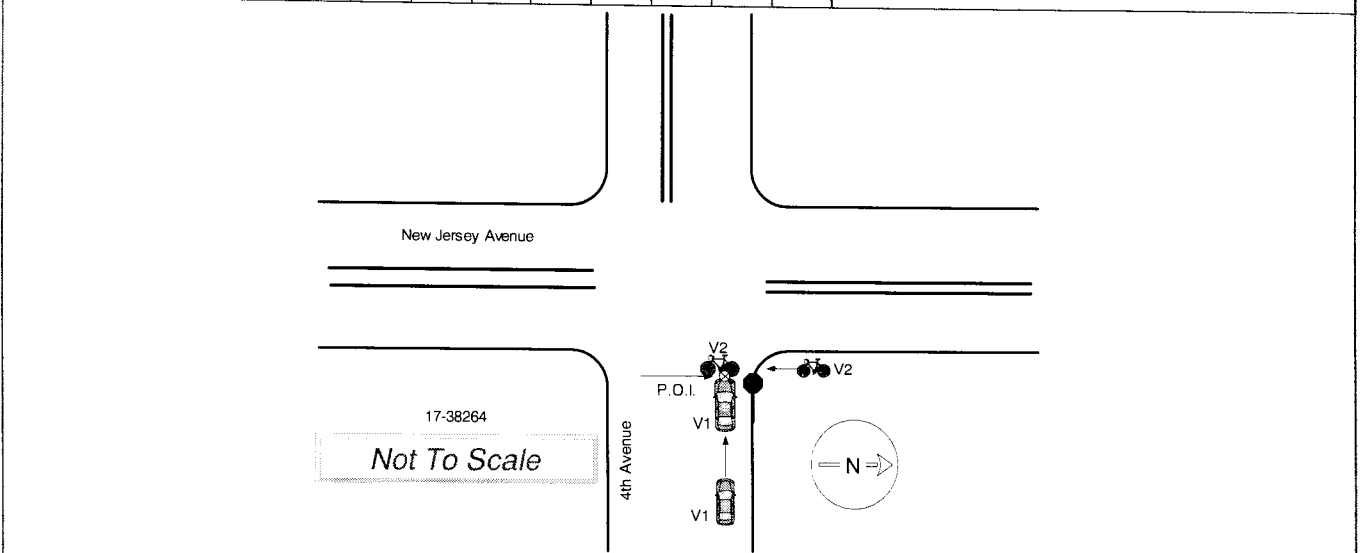

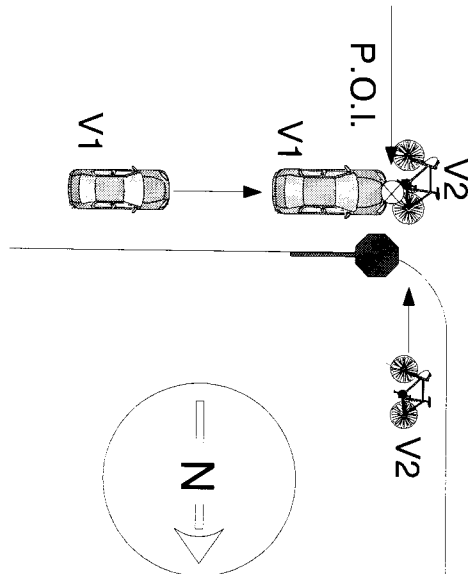
