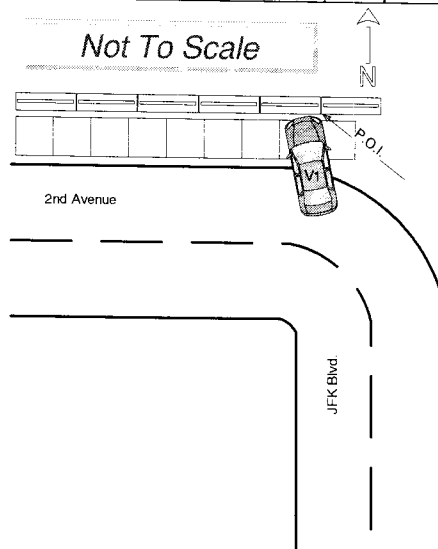

145. Crash Description/Narrative

Driver of V1 stated that he was arguing with his girlfriend, who was the passenger, when he failed to realize the road ended. V1 struck the curb at the end of JFK Blvd, followed by striking a trash can and the concrete seawall. The trash can was launched into the metal railing on top of the seawall causing the railing to bend and trash be strewn all over the sidewalk and street (see attached photos).

Witness, Thomas Matulewski, stated that he heard the crash and when he walked down towards the accident, he saw the driver running away from the accident after a female. It should be noted that the driver was located at 5th Avenue and JFK Blvd. The passenger was gone on arrival and we were unable to make contact with her. Driver 1 was transported to Cape Regional Hospital for a laceration on the knee and issued summonses.

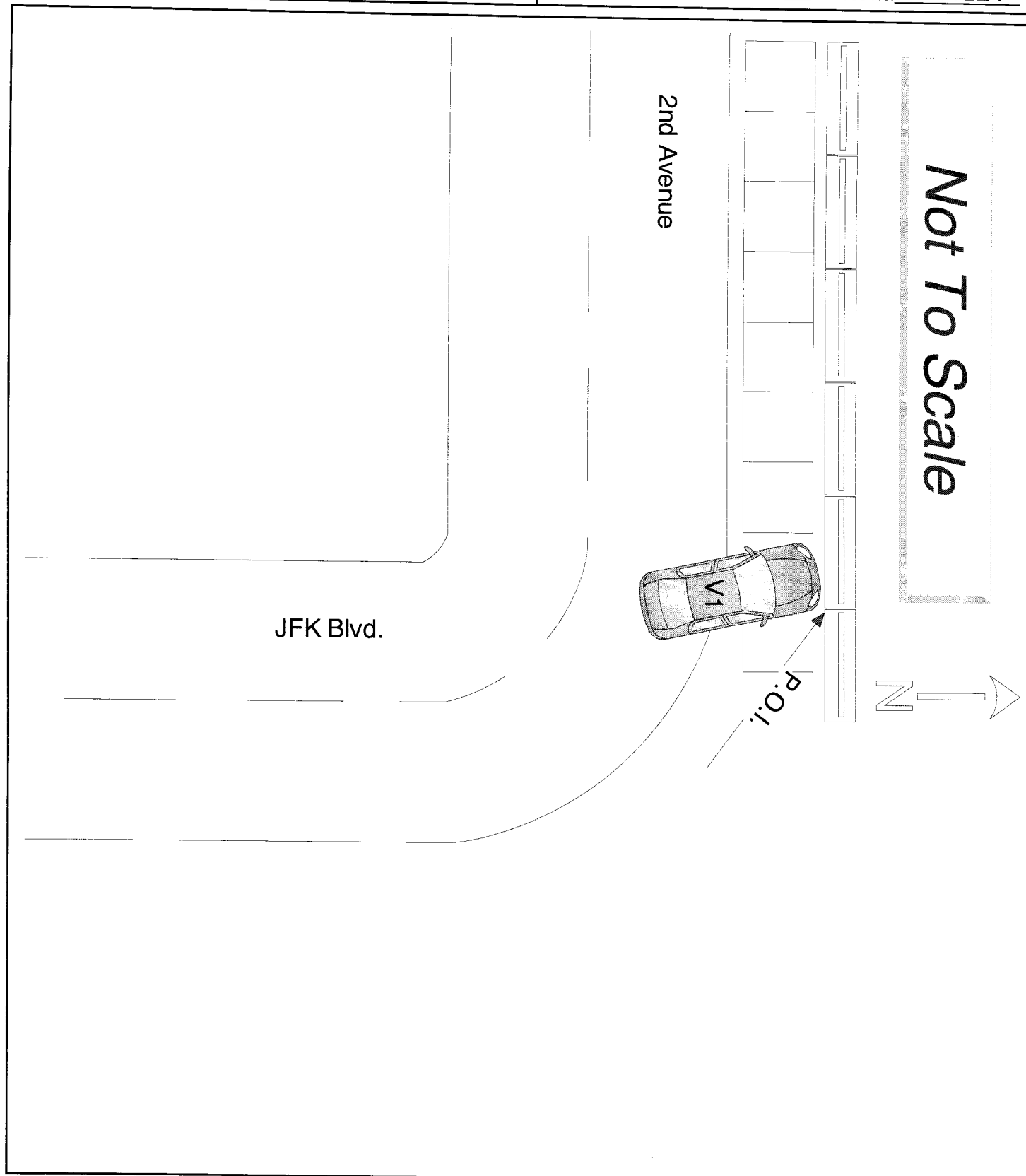
