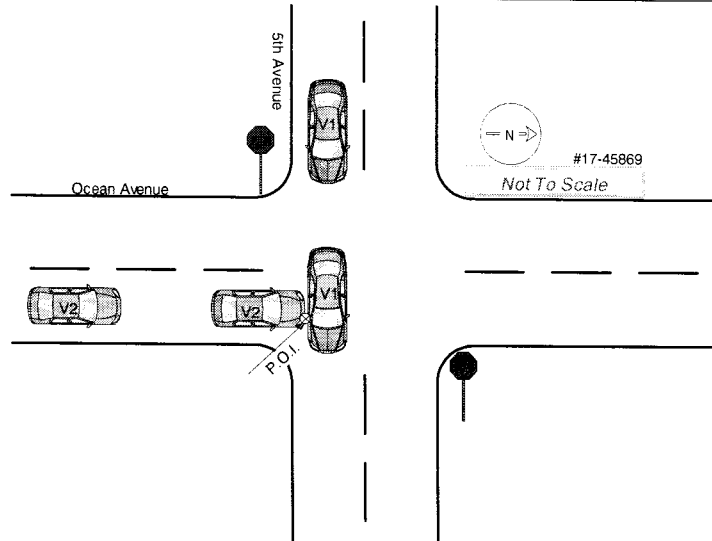

145. Crash Description/Narrative

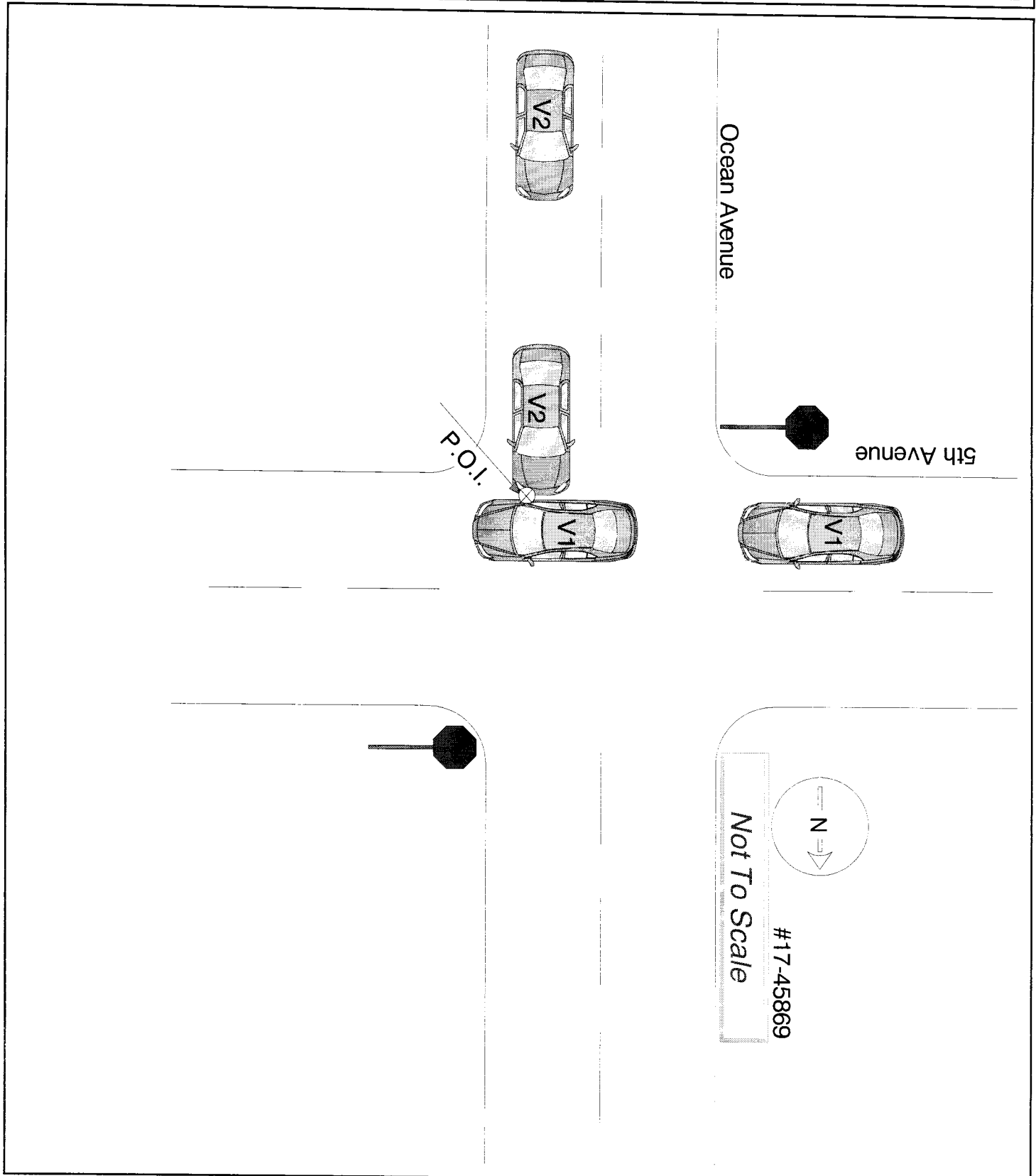
On the above date and time, I Officer Sunderhauf #1531 responded to an motor vehicle accident at 5th and Ocean Avenue. Upon my arrival I observed a vehicle bearing Pennsylvania registration HMJ4745 (vehicle 1) on the South side of the side walk facing East on 5th Avenue. I also observed another vehicle bearing New Jersey registration IM66YW (vehicle 2) sitting in the middle of the intersection facing North on Ocean Avenue.

I identified the driver of vehicle 1 to be Daniel Frederick. Frederick complained of minor stiffness in his right thumb. I also identified the driver of vehicle 2 Charlotte Mazzeo. Mazzeo complained of a small laceration to her right forearm. After speaking to both driver I was able to confirm both drivers injuries were minor. Both drivers refused medical attention.
