- 15.) The zip code the forfeiture took place
- 16.) Racial ethnicity of both parties. If several were involved, please list.

I may have follow-up requests contingent on the availability of the above data. I prefer Excel or .csv files. If you do not have access to those, I am content to take whatever form in which the data may be contained. I obviously will not disclose any sensitive information. This data is to be used in a dissertation analyzing the impact of incentives on police behavior and crime.

I understand there are limitations to the data you have available. For the data which has not been compiled yet into excel files, I will happily do so for the state and provide back in the course of my research. I will also share any results of my work with the state of New Jersey.

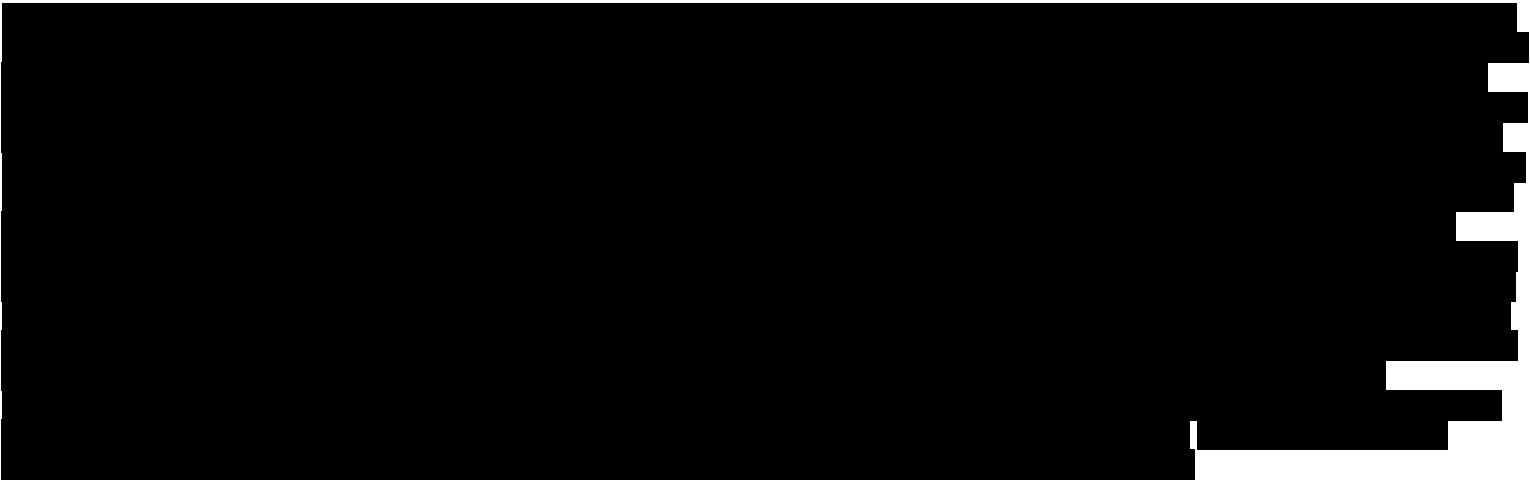

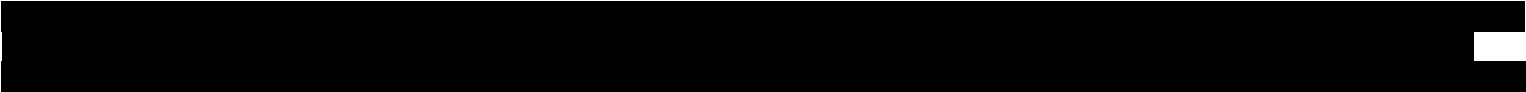
