12.1.17: Records responsive to your request are attached. The report has been redacted for one or more of the following reasons:

- (1) Social Security number, pursuant to N.J.S.A. 47:1A-1.1, which excludes Social Security number from OPRA's definition of "government record" or "record";
- (2) Federal Tax Identification Number (FEIN), which is analogous to a Social Security Number, excluded from OPRA's definition of "government record" or "record," N.J.S.A. 47:1A-1.1;
- (3) N.J.S.A. 47:1A-1, which provides that a public agency has a responsibility and an obligation to safeguard from public access information whose disclosure would violate a citizen's reasonable expectation of privacy. Such information includes, but is not limited to, home address, personal email address, and date of birth;
- (4) *Wolosky v. Somerset Cty.*, 2017 N.J. Super. Unpub. LEXIS 781 (App. Div. 2017), in which the Superior Court of New Jersey, Appellate Division, held that the "plaintiff does not have a right under OPRA to access the email and home addresses of persons who submit OPRA requests.";
- (5) Information "describing a natural person's finances, income, assets, liabilities, net worth, bank balances, financial history or activities, or creditworthiness," Executive Order No. 26 (McGreevey 2002), see N.J.S.A. 47:1A-1, and N.J.S.A. 47:1A-9;

In addition, information may not be disclosed to the extent it is part of investigative files in matters pending investigation, or in any completed investigations in which no formal disciplinary action was taken, is not a public record and is not disclosable under OPRA. N.J.A.C. 11:17-2.16(b)(6). See N.J.S.A. 47:1A-1 ("all government records shall be subject to public access unless exempt from such access by: [OPRA or] . . . any other statute . . . [or] regulation promulgated under the authority of any statute"), -9a ("The provisions of [OPRA] shall not abrogate any exemption of a public record or government record from public access heretofore made pursuant to [OPRA or] any other statute . . . [or] regulation promulgated under the authority of any statute"). The Department can neither confirm nor deny the existence of any such investigations.
