Dear Mr. Cunningham,

I am looking to obtain copies of certain annual audit reports for a specific district management corporation, the Weehawken S.I.D. Management Corporation, which has managed the Hartz Mountain/Lincoln Harbor Special Improvement District in Weehawken since 2003. From 2003 through 2015, these annual audits were required to be submitted to your office under N.J.S.A. § 40:56-88, that is until the statute was amended in 2015 to remove this requirement. Nevertheless, the pre-2015 statute had read:

The district management corporation shall cause an annual audit of its books, accounts and financial transactions to be made and filed with the governing body of the municipality, and for that purpose the corporation shall employ a certified public accountant of New Jersey. The annual audit shall be completed and filed with the governing body within four months after the close of the fiscal year of the corporation, ***and a certified duplicate copy of the audit shall be filed with the Director of the Division of Local Government Services in the Department of Community Affairs*** within five days of the filing of the audit with the governing body of the municipality.

Does your office maintain copies of these audits or other records related to this district management corporation, and if so, how can I go about obtaining copies of them? If you do not have copies of these audits, can you please direct me to the agency or individual that does have these audits on file? I appreciate your assistance in this matter, and feel free to call me with any questions.
