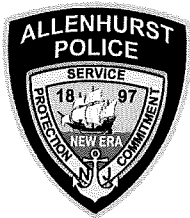

Narrative:										
Narrative										
Ptl Williams observed the above vehicle failing to maintain its lane at Ocean Avenue and Corlies Avenue. The vehicle was stopped at the above location, in Deal. The driver was identified as Nikesha Laguer, the registered owner. Ptl Eustace responded as backup. While Ptl Williams was speaking with Ms. Laguer, he detected the odor of an alcoholic beverage. Ms. Laguer was then asked to step out of the vehicle to conduct field sobriety tests, which she failed. Ms. Laguer was placed under arrest for driving while intoxicated. Atlantic Towing was called to impound the vehicle, in accordance with John's Law. Ms. Laguer was transported to Allenhurst Police Headquarters to be processed. Once at headquarters, Ptl Williams conducted the 20 minute observation and then Sgt Rogers operated the Alcotest. Ms. Laguer's provided breath samples, with a reading of .21% BAC. These readings were found to be within acceptable tolerances

Ms. Laguer was issued Allenhurst summonses F000968 for 39:4-50, F000969 for 39:4-88, F000970 for 39:3-66, F001341 for 39:3-33, and F001342 for 39:4-96, all with a mandatory court date of September 5th, at 4pm. Ms. Laguer was then released to a sober adult, Erica Brown.
