Dear Mr. Moran:

The Hudson County Prosecutor's Office (HCPO) is in receipt of your above request under the New Jersey Open Public Records Act, **N.J.S.A. 47: 1A-1, et. seq.** and the Common Law Right of Access. (Copy is attached for your easy reference.)

Please be advised that the New Jersey OPRA statute, **N.J.S.A. 47:1A-5(i)**, has been amended to reflect, during the COVID-19 emergency, that the seven (7) day deadline within which to respond to OPRA requests no longer applies. The government entity is only required to make a "reasonable effort, as the circumstances permit" to respond within seven (7) days or as soon as possible thereafter.

Attached please find a copy of an OPRA request from David Wildstein to the HCPO mentioning your name, Tom Moran, received by the HCPO on March 29, 2021.

There are no other records in the possession of the HCPO in response to your OPRA request. In addition, you requested the same records under the common law. Since the HCPO has provided you with a full response to your request, any discussion under the common law is moot.

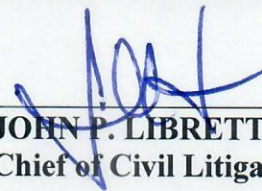
