At the date and approximate time, Ms. Valentine called in to report that her 12 year old child, N [redacted] : V [redacted] -T [redacted] didn't come home from school. I advised the dispatcher I would call Ms. Valentine and inform her that her child was with the father in Willingboro. Central Communications advised me they still had Ms. Valentine on the line and they would inform her of the same since all officers were currently working a case involving a missing 10 year old juvenile that had been located in High Street named Jimmy. Central Communications advised Ms. Valentine of the same but she requested a phone call. I spoke with Ms. Valentine and advised her that her son, N [redacted], and his father, Mr. Thomas, came to the police station to report that I [redacted] had been in some type of altercation with his mother, Nicole Valentine, and didn't want to go home. He wanted to go to his father's house which we felt was fine since he was twelve years old and that's where he wished to go. Ms. Valentine felt that it was in violation of a court order and Mr. Thomas shouldn't have gone to her house or the school to pick him up. I advised her we had no idea where Mr. Thomas meet up with his son and we have no proofs that he violated any order. Anything she was coming up with about him getting [redacted] from school or coming to her house was all just assumptions. The only order that officers are aware of is a final restraining order where Thomas is the plaintiff and Valentine is the defendant. Mr. Thomas wasn't interfering with the custody of a child and made it well know the child was with him and wanted to be with him. Based upon this, and the fact that Valentine confirmed the altercation with her son [redacted], where she reported that he put his hands on her, we felt it was best the child stay with the father for the time being to cool off. Valentine felt that Thomas was manipulating their child in common and was making him engage in this type of behavior when he was with her. I advised Ms. Valentine I would document the incident for her as a matter of record incase she needed any information from it in the future. At this time, the child is safe and with his father. Both parties were advised if they felt there was any type of abuse they could report it to DCP, to which I was advised that DCP was already contacted. Report Complete Sgt. Egler
