

PUBLIC NOTICE

NOTICE OF PRESUMED ABANDONED FUNDS ON DEPOSIT WITH THE CLERK OF THE SUPERIOR COURT

TAKE NOTICE that pursuant to N.J.S.A. 46:30B-1 et seq., the following funds presently on deposit with the Clerk of the Superior Court have remained on deposit and **UNCLAIMED** for a period of ten (10) years or more and are therefore presumed **ABANDONED**.

Pursuant to N.J.S.A. 46:30B-47.1, THE CLERK OF THE SUPERIOR COURT as holder of presumed abandoned property must make a report to the STATE TREASURER before November 1 of each year as of the preceding June 30, which report must state:

- (a) the name of the case in which the deposit was made;
- (b) the Court's docket or identifying number for the case;
- (c) the date the deposit was made;
- (d) the unpaid balance of the original sum deposited;
- (e) the interest or income earned on deposit; and
- (f) the total amount payable to the State Treasurer.

AND PURSUANT to N.J.S.A. 46:30B-50.1, the Clerk of the Superior Court, not more than 120 days and not less than 90 days before the date that the Clerk shall present the Report of Property Presumed Abandoned, as aforementioned, shall POST in his office and in each County Clerk's office where public notices are customarily posted, a NOTICE setting forth the case name and docket number of each case in which a deposit is presumed ABANDONED and indicating that if the apparent owner does not move to seek an ORDER to withdraw the sum on deposit within SIXTY (60) DAYS of the date of the posting of the NOTICE, the sum on deposit and all accretions shall be delivered to the State Treasurer, to whom all further claims shall be made;

THEREFORE, TAKE NOTICE THAT THE CLERK OF THE SUPERIOR COURT HEREBY DECLARES THAT THE ANNEXED LIST OF DEPOSITS ARE HEREBY PRESUMED ABANDONED AND THAT THE APPARENT OWNER MUST MOVE TO SEEK AN ORDER TO WITHDRAW THE SUM ON DEPOSIT WITHIN SIXTY (60) DAYS OF SEPTEMBER 1, 2019 AND THAT FAILURE TO DO SO WILL RESULT IN THE SUM ON DEPOSIT AND ALL ACCRETIONS BEING DELIVERED TO THE STATE TREASURER, TO WHOM ALL FURTHER CLAIMS SHALL BE MADE. THE MOTION MUST BE FILED IN THE COUNTY IN WHICH THE CASE ORIGINATED AND A COPY OF THE MOTION MUST BE MAILED TO, AND ALL INQUIRIES MADE TO, THE TRUST FUND UNIT, P.O. BOX 971, TRENTON, NEW JERSEY 08625, TELEPHONE (609) 815-2900.
