“ORDINANCE REPEALING ORDINANCE NO. 1966 OF THE TOWNSHIP OF BELLEVILLE AMENDING AN ORDINANCE ENTITLED, ‘AN ORDINANCE TO PREVENT LOITERING, LOUNGING, IDLING OR SLEEPING IN THE STREETS, PARKS OR PUBLIC PLACES AND PROVIDING PENALTIES FOR THE VIOLATION THEREOF.’”

BE IT ORDAINED BY THE MUNICIPAL COUNCIL OF THE TOWNSHIP OF BELLEVILLE, NEW JERSEY:

WHEREAS, the Council adopted on November 23, 1976 Town Ordinance No. 1966 wherein the Township of Belleville amended an Ordinance entitled “An Ordinance to Prevent Loitering, Lounging, Idling or Sleeping in the Streets, Parks or Public Places and Providing Penalties for the Violation Thereof”; and

WHEREAS, Town Ordinance No. 1966 is preempted by N.J.S.A. 2C:33-2, 2C:33-2.1 and 2C:33-7.

NOW, THEREFORE, BE IT ORDAINED:

1. That Town Ordinance No. 1966 adopted on November 23, 1976, entitled “An Ordinance to Prevent Loitering, Lounging, Idling or Sleeping in the Streets, Parks or Public Places and Providing Penalties for the Violation Thereof”, is hereby repealed in its entirety.

BE IT FURTHER ORDAINED, that all previous Ordinances inconsistent with this Ordinance are hereby repealed.

BE IT FURTHER ORDAINED, that this Ordinance shall become effective twenty (20) days after final passage, adoption and publication according to law.
