- (c) Improvement of the water supply and distribution system in and by the Township, including by the upgrade of the water main linings, together with all structures, equipment, site work, work and materials necessary therefor or incidental thereto, all as shown on and in accordance with the plans and specifications therefor on file or to be filed in the office of the Township Clerk and hereby approved
