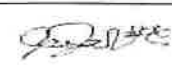

Trella was placed under arrest for CDS and Drug Paraphernalia. Trella was placed into patrol vehicle 2105 and transported to HQs for further processing.

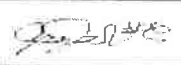

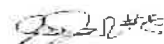
