ON MAY 26, 2019 AT 2359 HOURS I WAS DISPATCHED TO [REDACTED] CAPSTAN AVENUE FOR AN OVERDOSE. UPON ARRIVAL I OBSERVED A MALE ON THE FLOOR IN THE DOORWAY TO THE RESIDENCE. THE MALE WAS UNRESPONSIVE BUT WAS BREATHING AND HAD A PULSE. THE MOTHER, [REDACTED] ADVISED ME THAT [REDACTED] THE VICTIM, HAS BEEN USING HEROIN THE PAST FEW DAYS. PTL. ANTHONY AND PTL. CARLISLE ARRIVED ON SCENE AT THIS TIME. I THEN ADMINISTERED ONE DOSE OF NARCAN TO [REDACTED] AND PUT HIM ON OXYGEN. SHORTLY AFTER BEACHWOOD FIRST AID AND MONOC PARAMEDICS ARRIVED ON SCENE AND TOOK OVER TREATMENT.

[REDACTED] ADVISED OFFICERS THAT SHE SAW [REDACTED] COLLAPSE AND IMMEDIATELY CALLED 911. [REDACTED] ADVISED OFFICERS SHE CAUGHT [REDACTED] USING HEROIN THE OTHER DAY. LET IT BE KNOWN NO HEROIN OR DRUG PARAPHERNALIA WAS FOUND ON SCENE.

APPROXIMATELY 5 MINUTES AFTER THE DOSE OF NARCAN [REDACTED] BEGAN REGAINING CONSCIOUSNESS. [REDACTED] ADVISED OFFICERS THAT HE TOOK APPROXIMATELY 5 BAGS OF HEROIN AND THAT HE USED A SYRINGE. SHORTLY AFTER BEACHWOOD FIRST AID TRANSPORTED [REDACTED] TO COMMUNITY MEDICAL CENTER. PTL. ANTHONY WENT TO COMMUNITY MEDICAL CENTER TO REPLENISH THE NARCAN AND ALL OTHER UNITS CLEARED AND RESUMED PATROL.

I THEN WENT TO HEADQUARTERS AND FAXED A NALOXONE DEPLOYMENT FORM TO THE NEW JERSEY STATE POLICE AND OCEAN COUNTY PROSECUTOR'S OFFICE.

ON THE ABOVE DATE AND TIME BEACHWOOD POLICE WAS DISPATCHED TO [REDACTED] PACIFIC AVE FOR AN UNCONSCIOUS FEMALE. UPON ARRIVAL I WAS BROUGHT INTO THE RESIDENCE BY THE HOME OWNER AND SHOWN A FEMALE LYING ON HER BACK IN THE DOOR WAY TO THE DOWN STAIRS BATHROOM. U/S IDENTIFIED THE FEMALE FROM A PRIOR OVERDOSE INCIDENT AS [REDACTED] I ADMINISTERED ONE DOSE OF NARCAN NASAL FOR HEROIN USE. VICTIM WAS GIVEN OXYGEN AND A SECOND DOSE OF NARCAN APPROXIMATELY 5 MINUTES LATER, WITH OFFICER O' CONNER STARTING WITH A BVM BREATHING, FOR ASSISTANCE.

BEACHWOOD BLS ARRIVED AND TOOK OVER PATIENT CARE, TRANSPORTING SUBJECT TO CMC FOR FURTHER MEDICAL CARE. OFFICER APEL RESPONDED TO CMC FOR NARCAN REPLENISHMENT. WAX FOLDS WERE FOUND MARKED WITH "FANTASTIC " IN AREA OF PATIENT. ITEMS RECOVERED WERE PROPERLY BAGGED AND PLACED INTO SHORT TERM EVIDENCE LOCKER FOR FUTURE DESTRUCTION.
