On 08/10/2019 at 1700 hours PO Barker, PO Waterson and I, PO M. Nickerson responded to [REDACTED] for a report of a [REDACTED] year old [REDACTED] unconscious, possible overdose. On arrival, I retrieved my Narcan kit and entered the residence.

While in the residence, I made contact with the [REDACTED] who was unconscious on the bathroom floor. I recognized the [REDACTED] as [REDACTED]. I removed an uncapped hypodermic needle from [REDACTED] right hand and placed it in the sink. I deployed the Narcan to [REDACTED] left nostril and I began a sternum rub. Also, [REDACTED] had a strong pulse. PO Barker and PO Waterson join me in the bathroom and rescue breaths were started. Several minutes later, [REDACTED] regained consciousness.

[REDACTED] was brought into the kitchen area and was seated in a chair. Pt Boro F/A and Medic 205 arrived on scene and took over care of [REDACTED]. Ultimately, [REDACTED] refused to be transported to the hospital and refused any further medical treatment. [REDACTED] signed off indicating [REDACTED] did not want any further assistance.

I secured the hypodermic needle in a sharps container and brought it to Brick ER. While at the hospital, I discarded the needle and replenished my Narcan kit. All proper Narcan paperwork was completed and submitted to PO Aurin for review.

On 08/21/2019 at 2111 hours I, PO M. Nickerson responded to [REDACTED] for a report of a [REDACTED] year old [REDACTED] unconscious/not breathing, possible heroin overdose. On arrival, I retrieved my Narcan kit and entered the residence. I made my way to the upstairs bathroom, where I found [REDACTED]. [REDACTED] had agonal breathing and was laying on [REDACTED] side.

Once I discovered [REDACTED], I detected a strong pulse but [REDACTED] was unconscious. I removed a hypodermic needle, which was still in [REDACTED] right thigh, and placed it in the sink. I deployed Narcan into [REDACTED] right nostril and moved [REDACTED] into the recovery position. I began a sternum rub and attempted to wake [REDACTED]. Shortly after deploying the Narcan, Pt Boro First Aid arrived on scene and took over care of [REDACTED]. They deployed a second dose of Narcan to [REDACTED].

[REDACTED] was able to regain consciousness about 5-8 minutes after being given the Narcan. [REDACTED] was assisted down the stairs by first aid members and agreed to be transported to the hospital. I secured the needle in a sharps container. I left a pamphlet with information about help with addiction for the family. [REDACTED] was transported to Brick Hospital without incident.

I responded to Brick Hospital and replenished my Narcan kit and disposed of the needle. I completed the proper paperwork and submitted it to PO Aurin for review.

		Responded to location for a 911 call for a [REDACTED], in the bathroom, huffing something, which was causing convulsions. Upon arrival, I met with [REDACTED]. [REDACTED] let me in the residence and said that [REDACTED], [REDACTED], was in the bathroom. We walked to the bathroom door and [REDACTED] advised [REDACTED] that the Police were here. [REDACTED] opened the door and was breathing heavily. [REDACTED] was very excited so I asked [REDACTED] to sit down in the kitchen. I asked dispatch to send the First Aid. As I was speaking with [REDACTED], [REDACTED] slowly began to calm down. First Aid arrived and provided medical assistance. [REDACTED] admitted that [REDACTED] had a problem. First Aid advised that [REDACTED] had [REDACTED] and [REDACTED] wanted to go to the Hospital. First Aid transported [REDACTED] to Brick Hospital.
