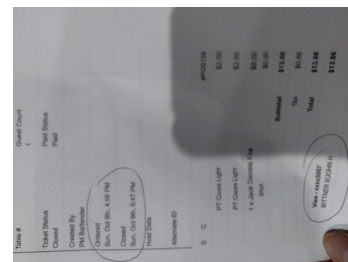

Harassment / Threats

October 9th-10th, 2022

On October 10th, 2022, I, Patrolman Christopher B. Sullivan #690 was on uniformed patrol in Howell Township operating marked patrol vehicle #19. I was assigned to the sector seven area of the Township. At approximately **15:12** hours, I was dispatched to Howell Township Police Headquarters in reference to an individual in the lobby wishing to report an instance of harassment/threats. It should be noted that the individual explained that the incident had occurred in the past and no immediate threat was imminent.

Upon arrival at Howell Township Police Headquarters, I met with the reporting party in the lobby a Kimberly **Shulskie** (W/F/45/Jackson). Shulskie explained that she has been the manager at The Ivy League in Howell (2701 U.S. 9-N.B.) for approximately four years. Last night (10/09/2022) she was working at the establishment. Shulskie continued and explained that while working, a chant ensued which sounded like "Lets Go Brandon" according to Shulskie. According to Shulskie, this chant could have been portrayed in a negative light to customers, and been taken as an insult. Shulskie explained that in her experience working at the establishment, similar chants have started arguments and altercations. Shulskie pursued onward and stated that she responded over to the individuals that were voicing this chant, and attempted to de-escalate the occurrence. At this time, Shulskie explained that the male individual at the bar voiced "Fuck you" in her direction. In addition, Shulskie explained that the male then got out of his seat and stood in front of her in an aggressive manner.

John Bittner (W/M/53/Howell) as well as a Pamela Richmond (W/F/53/Howell). Shulskie continued and Shulskie also mentioned that Richmond threatened to have her fired from her place of work, as well as threatened to spit in her face. Shulskie then explained she told them to pay their checks and leave the premises.

Richmond was contacted via telephone and advised that she was indeed at the Ivy League last night. Richmond continued and stated that she was chanting the "Lets Go Brandon" chant for the ongoing game on the television with numerous other customers. At this time, Richmond explained that Shulskie screamed at her as well as Bittner. Richmond then continued and explained that Shulskie threatened to make them leave the establishment. Bittner was also telephoned and stated that they were watching baseball at the bar when someone started a "Lets Go Brandon" chant and he also began chanting. Bittner then explained that Shulskie came over to them and screamed "you cant say that". Bittner then explained that the two engaged in a verbal argument over the subject. Nothing physical, no threats reported by Richmond or Bittner. SEE OF.
