The Township of Pennsauken received your Open Public Records Act (OPRA) request on April 16, 2019. I, as the records custodian, received your OPRA request on April 16, 2019. As such, the seven (7) business day deadline to respond to your request was April 26, 2019. (see attached) A response is provided to you on the 5th business day after the custodian's receipt of said request

The attached records are being provided in their entirety and are responsive to #'s 1 and 5 of your request. Please be advised that with regard to #'s 2 to 4 of your request, the Township of Pennsauken has no records responsive to your request.

If your request for access to a government record has been denied or unfilled within the seven (7) business days required by law, you have a right to challenge the decision by the Township of Pennsauken to deny access. At your option, you may either institute a proceeding in the Superior Court of New Jersey or file a complaint with the Government Records Council (GRC) by completing the Denial of Access Complaint Form. You may contact the GRC by toll-free telephone at 866-850-0511, by mail at P.O. Box 819, Trenton, NJ, 08625, by e-mail at grc@dca.state.nj.us, or at their web site at www.state.nj.us/grc. The GRC can also answer other questions about the law. All questions regarding complaints filed in Superior Court should be directed to the Court Clerk in your County.
