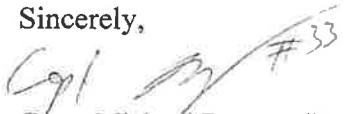

**NARRATIVE**

On 07/30/2023 the Keansburg Police and Fire Departments stood by during a memorial motorcycle and car ride for Gregory Tutt Jr, who recently passed away. During the event an estimated 150 vehicles were present, many of which were performing burn outs and donuts in the roadway outside of Crystal Bay apartment complex. After the large crowd was dispersed by patrols, multiple skid marks and burned rubber were present on the roadway. A small portion of the blacktop on Carr Avenue, near the entrance of the Crystal Bay apartment complex, presented with indentations following the event. Chief A. Gogan and the D.P.W. supervisor Rogan were both notified.
