The Curious Taxpayer

Re: OPRA Request dated October 14, 2023

Dear Curious Taxpayer:

You recently requested documents from the Perth Amboy Board of Education ("Board" or "District") pursuant to an Open Public Records Act ("OPRA") request dated October 14, 2023. The time in which a public entity has to respond to an OPRA request begins to run the day after the custodian of records receives such a request. Your request was received by the District on October 16, 2023. The seventh (7th) business day within which to respond to your request is October 25, 2023. At that time, the District anticipated providing a response to your request by November 22, 2023.

At this time, the following is provided in response to your request.

1. **A digital list of all employees hired by the district. Please include their job title (non abbreviated) and union affiliation, department they work in, hire date, and salary. Please include full time staff, part time staff, substitutes, or temporarily/seasonally employed workers. This list can be broken up if one record does not exist containing all the requested information.**

Please be advised that your request is overly broad, vague, and/or unclear, as it fails to set forth a date or date range, thereby failing to identify with reasonable clarity the specific government records to which you seek access. See MAG Entertainment, LLC v. Division of Alcoholic Beverage Control, 375 N.J. Super. 534 (App. Div. 2005); Bent v. Stafford Police Dep't, 381 N.J. Super. 30 (App. Div. 2005). In this regard, the Appellate Division has held that "[w]hile OPRA provides an alternative means of access to government documents not otherwise exempted from its reach, it is ***not intended as a research tool*** litigants may use to force government officials to identify and siphon useful information. Rather, OPRA simply operates to make identifiable government records 'readily accessible for inspection, copying, or examination.' N.J.S.A. 47:1A-1." (Emphasis added.) MAG Entertainment, LLC at 546. The Court further held that "[u]nder OPRA, agencies are required to disclose only 'identifiable' government records not otherwise exempt ... In short, OPRA does not countenance open-ended searches of an agency's files." (Emphasis added.) Id. at 549.
