The City of Linden received your Open Public Records Act (OPRA) request on August 27, 2020. The official Records Custodian, Joseph C. Bodek, received your OPRA request on August 27, 2020.

You requested the following: See Attached

The records are now being provided to you as per your request, with redactions. In accordance with N.J.S.A. 47:1A-1 (24) Privacy Interest, N.J.S.A. 47:1A-1.1(16) Personal Identifying Information, N.J.S.A. 2A:4A-60 (Juvenile Records and N.J.S.A. 47:1A-9(22) which upholds exemptions contained in other State or Federal Statutes and regulations, Executive Orders of the Governor, Rules of Court, Constitution of this State, or judicial case law are exempt as their disclosure would violate the U.S. Department of Health & Human Services Health Information Privacy Rule (HIPAA). The Privacy rule protects all “individually identifiable health information” held or transmitted by a covered entity or its business information “protected health information (PHI).

If you feel that your request for access to a government record has been improperly denied or unfilled within the seven (7) business days required by law, you have a right to challenge the decision of the City of Linden to deny access. I have attached information, from the Government Records Council regarding the process to file a complaint.

New Jersey Government Records Council ("GRC")



What to do if your request for a record has been denied

The New Jersey Open Public Records Act (N.J.S.A. 47:1A-1 et seq.) permits a person who believes that he or she has been unlawfully denied access to a public record either to file a complaint with the GRC or to file suit in Superior Court to challenge the decision and compel disclosure. This poster describes the procedures for taking such actions.

To file a complaint with the GRC:

- Visit the GRC's website at www.nj.gov/grc for information and to register your complaint. In the alternative, you may contact the GRC by telephone at 1-866-850-0511 or by e-mail at government.records@dca.nj.gov.
- When you file the written complaint, the GRC will offer both you and the public agency non-adversarial, impartial mediation. If mediation is not accepted or is not successful, the GRC will investigate the complaint.
- In some cases, the GRC can award attorney's fees to a complainant or impose a fine against a records custodian.
- There is no fee to file a complaint with the GRC.

To file a complaint in Superior Court:

- A requestor may start a summary (expedited) lawsuit in the Superior Court. A written complaint and order to show cause must be filed with the court.
- The court requires a filing fee, and you must serve the lawsuit papers on the appropriate parties.
- The court will schedule a hearing to resolve the dispute.
- If you disagree with the court's decision, you may appeal the decision to the Appellate Division of the Superior Court.
- If you are successful, you may be entitled to reasonable attorney's fees.
- You may wish to consult with an attorney to learn about initiating and pursuing a summary lawsuit in the Superior Court.
- Filing suit in Superior Court may result in a faster resolution, because the courts adjudicate cases every day, whereas the GRC only meets once a month.

On March 31st, 2018 at 1021 hours, while patrolling in marked Unit 705, I was dispatched to 800 Clark Street on a report of a custody issue.

Upon arrival, I spoke with Peter Brown, who stated he had a verbal agreement with his ex-wife (Elena Brown) pertaining to him having custody of [REDACTED] during the Spring Break from school. However, she is now refusing to allow him custody. Mr. Brown continued to state, he has a court order stating he is to have custody during the American Easter and Ms. Brown during the Romanian Easter. However, he failed to provide any documents stating so.

I then spoke with Ms. Brown, who provided a court order (FM-20-001119-14W) filed September 25th, 2014 by the Honorable Thomas J. Walsh stating the [REDACTED] is to have custody of the [REDACTED] during Easter on the even years and the [REDACTED] during the odd years. She also provided other court orders that did not pertain to the custody of the [REDACTED]

As I continued to speak with Ms. Brown, the [REDACTED] boarded a white Honda Civic (NJ-E96JFT) driven by Mr. Brown's fiancée (Joanna V. Diaz). I was later informed the [REDACTED] were taken to the 8th Ward Park for the Easter Egg Hunt.

Shortly after, Sgt. Melchionna arrived on scene and began to speak with Mr. Brown as I continued to speak with Ms. Brown.

Ms. Brown continued to state, she did not agree to give custody of the [REDACTED] to Mr. Brown. However, she did agree to give custody for one day next week so they may go to the United Nations building in New York. She then showed me the text message exchange between her and Mr. Brown corroborating her statement.

As per Sgt. Melchionna, we did not remove the [REDACTED] from the residence. Mr. and Ms. Brown were then informed of the decision and the family court complaint procedure.

Sgt. Melchionna and I then responded to the 8th Ward Park, where we met with Ms. Diaz to check on the welfare of the [REDACTED]. [REDACTED] appeared to be in good mental and physical health.

On 8/2/2018 at approximately 2203 hours, I responded to Rent-A-Center (312 N. Wood Avenue) in marked unit 703 on the report of a broken glass window.

Upon arrival with marked unit 717 (Sgt. Richmond) we spoke with the caller Maurice A. Munn. He explained that he is a driver for First Student Transportation and was detailed on this evening to transport [REDACTED] employees from their place of work at Six Flags (Jackson, NJ) as per a [REDACTED] work program named the Special Improvement District (S.I.D., 403 N. Wood Avenue) located in Linden. Mr. Munn further explained that while dropping the group of approximately 20-30 [REDACTED] off in the area of 300 N. Wood Avenue, one juvenile [REDACTED], who he believes to be named [REDACTED] (NFI), became irate and began to argue with him. Once [REDACTED] exited the bus, [REDACTED] punched a nearby glass window at the front of Rent-A-Center, which shattered it. [REDACTED] then left the area, walking southbound on N. Wood Avenue with multiple other [REDACTED]

Mr. Munn described [REDACTED]

[REDACTED] He further stated that [REDACTED] and was wearing a grey t-shirt. A check of the surrounding area was done by multiple marked units, yielding negative results for [REDACTED] or anyone matching [REDACTED] description.

Mr. Munn continued to explain that he often has problems with [REDACTED], and the two exchange words on a frequent basis. He further stated that [REDACTED] has brought this up to the work program before, and will do so again due to [REDACTED] actions this evening. Mr. Munn then provided me with contact information of the person in charge of the S.I.D. program, Peter Brown. I called Mr. Brown on marked unit 703's vehicle cell phone and explained this incident's details. Once I explained this incident in detail to Mr. Brown and provided him with Mr. Munns description, he also stated he believes this [REDACTED] Mr. Brown went on to state that he was unable to provide

me with any of [REDACTED] personal information at this time as the building with all the [REDACTED] information does not open until 9 a.m. He further stated that once he is able to obtain further information on [REDACTED] he would make contact with the Linden Police Department.

At this time the Linden Fire Department arrived on scene as well as Rent-A-Center manager Bladimir Perez. With Mr. Perez present, LFD proceeded to clean up any excess glass from the sidewalk. They then secured the 5ft. x 8ft. open window frame with wood ensuring that no one could gain entry to the building.

On scene, Mr. Perez could not provide me with an exact price for the broken window, stating he believed it cost approximately \$500.00. Photographs of the window were taken on marked unit 703's vehicle cell phone and uploaded to Evidence.com under this case number.

Brown states Mannhuber writes articles about him on the website and before publishing them, he emails Brown asking for any comments he would like to make about the articles. All contact has been via email up to this point. Brown states after the articles are posted online, Mannhuber tags various social media outlets however none of them are Brown's pages. Brown didn't have too much identifying information on Mannhuber but he believes he may have seen him while inside the SID office back in July 2018. That office is located at 401 N. Wood Avenue, Linden, NJ. Brown describes him as a white male, heavy set, approximately 50yoo with short hair.

On this date, Brown wants to specifically report that on April 4, 2019, Mannhuber wrote an article about him on the above mentioned website. Brown states the article alleges that Brown had a dating relationship with a woman named Alena and that Alena owned a cleaning company. Brown states the article accuses him of using his political influence to secure a cleaning contract for Alena at a Meridia property and also allows her to use undocumented illegal workers. Brown denies all these allegations and feels harassed by the article and the fact Mannhuber posted links to this article on various social media outlets.

Brown was sent link for evidence.com to send photos of the web pages, articles and any links to social media pages where the articles were found to have been tagged. He was given a case # and advised of complaint procedures.

Brown believes Mannhuber and Roman are owners or administrators of these two companies or buisnesses, namely "Ethicswatch LLC" and " B-Bear media" and that Mannhuber and Roman have been using these buisnesses to contact him, citizens in Linden, NJ and Dover, NJ in an effort to harass him. Brown believes that these buisnesses are based in Florida. He contacted their State's Attorney Generals office who advised him to make a police report in Linden, NJ. Brown states he has emails and other related documuments and asked for a evidence.com citizen link so he could share the files.

Brown also stated that he was transported to the hospital in January 2019 and Roman and Hickey were referencing this situation during a Linden City council meeting in the months thereafter. Brown also learned that an OPRA request was submitted by "ethicswatch llc" in which they asked for all Linden Police CAD incidents for that one specific day. A request Brown believed was centered around obtaining information about his [REDACTED]

Finally, Brown added that he has spoken to Robert Scutro in regards to "ethicswatch.com." Scutro informed Brown that Roman asked him to create an email account for ethicswatch.com some time ago. Brown was sent an evidence.com citizen upload link. Brown stated he is already aware of complaint procedures.

While checking his facebook account, he found that he was tagged in a post made by a JohnThe Eagle (facebook.com/l.teezy), whom he believes to be Mr. John Kaczor. Mr. Brown currently has court cases pending, regarding alleged harassment, against Mr. Kaczor. In the post (timestamped as being posted at 17:01 hours today), which is entitled Fun with OPRA, there is a short clip attached from a Linden Police officers body cam video that was recorded during a previous report Mr. Brown made at Linden Police Headquarters. Mr. Brown then showed me a screenshot of the posting, as well as the notification of the request for OPRA access to the video. The OPRA request was made by Ethics Watch New Jersey, which Mr. Brown stated is a moniker used by Mr. Kaczor.

Mr. Brown currently has a harassment complaint pending against Mr. Kaczor and is aware of complaint procedure. Mr. Brown was provided with the case number to this report as well as a digital upload link to attach the screenshot he took of the posting to this report via the Linden Police Department evidence.com database.
