I write as a resident of the 6th Congressional District of New Jersey, and a registered Democrat residing in Sea Bright, New Jersey. Pursuant to NJSA Title 19, Article 13, Section 5, the following is my challenge for the petition filings of Amani Al-Khatahtbeh, mailing address PO BOX 90, Milltown, NJ 08850, who has filed for the Democratic Primary in the 6th Congressional District of New Jersey.

In short, I object to the validity of every signature presented in the petition and to the registration status of every signatory. There are numerous frank and disqualifying failures in the petition which call into question the whole of the petition as filed.

The Filer has failed to meet the minimum requirement of 200 signatures of registered voters in the 6th Congressional District. Having filed with approximately 339 signatures, at least 151 signatures are invalid on their face and do not meet the requirements of NJSA.

The petition is replete with errors. First, and most glaring, of the invalid signatures, there are at least 98 signatures that are not made by a person in Congressional District 6. Second, there are at least 34 duplicate signatures. Third, at least 85 with an invalid address or no address at all. Fourth at least 22 were presented without a proper signature or are invalid for another reason as of March 30, 2020. This leaves the candidate with less than 140 valid signatures, 60 signatures short of the required minimum 200 signatures.

Please find two catalogues on spreadsheets along with this letter documenting the invalid signatures and specific challenges for each. *Exhibit A* attaches a challenge to the handwritten signatures. *Exhibit B* challenges all electronic signatures.

Governor Murphy's Executive Order EO-105 states: "4. The verification requirements of N.J.S.A. 19:23-11, insofar as they are not included on the online form created by the Secretary of State, shall be suspended for petitions due by 4:00 p.m. on March 30, 2020."

However, Gov. Murphy's Executive Order excepted only the online forms from witness verification requirements. EO-105 did *not* create any such exception hand written signatures from affidavit requirements. N.J.S.A. 19:23-11, requires that signatures must be attested to by a witness with a notarized statement. EO-105 does not remove this requirement from hand written signatures.

Here, Amani Al-Khatahtbeh did not submit a notarized witness form with the handwritten signatures. Therefore, every single one of the handwritten signatures which were submitted were not witnessed by a notarized affidavit of the person who circulated the petition and witnessed signatures. All of the handwritten signatures are also invalid per NJSA 19:23-11 and should not be considered.

In light of all of the foregoing noncompliance, candidate Amani Al-Khatahtbeh should be disqualified.

Please advise as to the date and time of any hearings on this challenge.
