IN MEMORIAM

Thomas F. Shebell, Sr.
(1927-1986)

I was provided via email this afternoon with additional petitions containing signatures. I was originally provided with 339. There are now 378.

A review of these petitions shows that the minimum requirement of 200 signatures has still not been met. Of the 378:

98 signatories are outside Congressional District 6.

45 are duplicates.

85 have an invalid address or no address at all.

22 were presented without a proper signature or are invalid for another reason as of March 30, 2020.

As a result of the aforementioned, there are 250 improper petitions of the 378 and well short of the 200 required.

I previously attached two spreadsheets documenting prior errors. I am attaching an additional spreadsheet here identifying additional errors on the petitions. See Exhibit C.

In light of all of the foregoing noncompliance, candidate Amani Al-Khatahtbeh should be disqualified.

Please advise as to the date and time of any hearings on this challenge.
