THE COMPLAINANT CALLED REPORTING THE SMELL COMING FROM TFH PUBLICATIONS IS UNBEARABLE. SHE REQUESTED SOMEONE SPEAK WITH TFH ABOUT THE SMELL.

I RESPONDED TO THE COMPLAINANTS HOUSE AND SPOKE WITH HER ABOUT THE SMELL. SHE ADVISED SHE CAN'T STAND THE SMELL COMING FROM TFH PUBLICATIONS ANYMORE. SHE REPORTS SHE CAN'T SIT IN HER BACK YARD OR LEAVE HER WINDOWS OPEN AS THE SMELL IS SO OVERPOWERING AND ANNOYING. SHE REQUESTED I SPEAK WITH SOMEONE AT TFH ABOUT THE SMELL BECAUSE FOR THE AMOUNT OF TAX DOLLARS SHE PAYS SHE WANTS SOMETHING DONE.

I RESPONDED TO THE MAIN OFFICE OF TFH AND SPOKE WITH INVOLVED JOHN COLLAZO BY TELEPHONE. HE WAS ADVISED OF THE COMPLAINT AND ASKED WHAT THE SMELL IS. HE REPORTED THE SMELL IS A NORMAL SMELL ASSOCIATED WITH THE TYPE OF PET PRODUCT MANUFACTURING DONE AT THE PLANT FOR APPROXIMATELY 15 YEARS NOW. HE REPORTED NOTHING INVOLVED WITH THE MANUFACTURING WILL SPOIL SO THE SMELL WOULD NOT BE RELATED TO ANY ROTTING MATERIALS.

HE ADVISED HE WILL HAVE ALL OF THE COMPANY DUMPSTERS EMPTIED AND A DEODORANT ADDED TO THE VENTILATION SYSTEM IN AN EFFORT TO REDUCE THE SMELL. OTHER THAN THAT, THERE ISN'T MUCH MORE HE CAN DO ABOUT THE SMELL AS ALL OF HIS EQUIPMENT HAVE PASSED INSPECTIONS RELATING TO PROPER VENTILATION.

I CONTACTED THE COMPLAINANT BY PHONE AND LEFT A MESSAGE ON AN ANSWERING MACHINE ADVISING HER OF THE EFFORT MR. COLLAZO WILL MAKE TO REDUCE THE SMELL.
