The Ocean County Sheriff's Office received your Open Public Records Act (OPRA) request on or about November 18, 2024. The official Records Custodian, Michael J. Zolezi, received your OPRA request on November 19, 2024.

The following records were requested:

- "All emails sent or received from Chris Raimann's county email during the dates of 10/10/24 until 11/11/24, including message contents.
- Chris Raimann cell phone records for the dates of 4/1/24 to 11/11/24, including inbound and outbound call logs and text messages.
- All emails sent and received between Chris Raimann and Mayor Daniel Rodrick from 1/1/24 to 11/18/24, including content."

The following is a line-by-line response to your requested items.

A. Requested records

1. All emails sent or received from Chris Raimann's county email during the dates of 10/10/24 until 11/11/24, including message contents. **The "New Standard (N.J.S.A. 47:1A-5(g))" has three components; Specific job titles and/or accounts; Specific subject matter; Reasonable time period.**

Kindly provide clarification to your OPRA request indicating the specific job titles and/or email accounts; specific subject matter of the emails; reasonable time period for the emails so we can proceed accordingly. Should this Office not receive clarification by close of business on Friday, 12/6/2024, the County will consider this OPRA request withdrawn and closed.

2. Chris Raimann cell phone records for the dates of 4/1/24 to 11/11/24, including inbound and outbound call logs and text messages. **The "New Standard (N.J.S.A. 47:1A-5(g))" has three components; Specific job titles and/or accounts; Specific subject matter; Reasonable time period. Be advised that the service provider WILL NOT provide text message content without a COURT ORDERED Subpoena.**

Kindly provide clarification to your OPRA request indicating the specific job titles and/or phone numbers; specific subject matter; reasonable time period for the calls/text messages so we can proceed accordingly.

OPRA: RIGHT OF APPEAL

If your request for access to a government record has been denied or unfilled within the seven (7) or fourteen (14) business days required by law, you have a right to challenge the decision by the responding agency to deny access. At your option, you may either: 1) institute a proceeding in the Superior Court of New Jersey; or 2) file a complaint with the Government Records Council ("GRC") by completing the Denial of Access Complaint Form. All questions regarding complaints filed in Superior Court should be directed to the Court Clerk in your County. Questions regarding the GRC's Denial of Access Complaint process can directed to the GRC toll-free telephone at 866-850-0511, by mail at PO Box 819, Trenton, NJ, 08625, by e-mail at Government.Records@dca.nj.gov, or at their web site at www.state.nj.us/grc. The Council can answer general inquiries about OPRA.

The GRC can also answer other questions about the law. All questions regarding complaints filed in Superior Court should be directed to the Court Clerk in your County.
