This office is in receipt of your OPRA request dated August 1, 2019. Please be advised that Meg Smith, Planning and Zoning Boards Secretary, reviewed and did the research for your request. There were no permits taken out for 470 Chestnut Ridge Road from 2015 to 2019. Attached is a summary of the permits that were taken out for 530 Chestnut Ridge Road from 2015 to 2019. Also attached is the tax sheet for those two addresses.

I emailed Mr. Anzevino because I had not received a response from him. He indicated that he received the request and went to check the file folder and he could not locate the file folder. They filed for the fire suppression system in either 2016 or 2017 he believes but that system could have been in place for years before and they only applied for the deduction then.
