Supplement

On the above date & time I Ptl. Leicht #296 & Sgt. Covone #260 were dispatched to 149 Brindletown Rd. for a report of a MVA involving 1 vehicle striking a gate. While in route to the residence Ocean County dispatched informed officers the vehicle involved in the incident is attempting to leave the property, and that the vehicle ran over someone's foot. Upon arriving on scene I spoke with Albert Canka who stated he was attempting to leave the property when he saw a white pickup truck driving down the driveway at a high rate of speed, he also stated the truck drove through the gate, causing his foot to get hit. Mr. Canka refused medical attention at this time, and stated he would seek medical attention on his own time. Mr. Canka stated the suspect was his neighbor Danilee Watkins. Mr. Canka, and Tina Marie Russo-Vega both had video footage of the incident which is attached to this report. Sgt. Covone watched the video footage on scene.

At this time I contacted Ocean County Dispatch to get in touch with an on duty AP. I spoke with AP Steve Berke giving him the details of the incident. AP Berke stated Mr. Watkins could be charged with Assault, and Criminal Mischief (2C:12-1c.(1) & 2C:17-3). After speaking with AP Berke officers requested the video footage via email which I provided them with. At this time myself, and Sgt. Covone drove to Mr. Watkins side of the property where we observed Mr. Watkins standing outside. Sgt. Covone read Mr. Watkins his Miranda Rights, and I patted him down for any potential weapons. Mr. Watkins stated the gate was partially open and the other party attempted to close it while he was driving in. Sgt. Covone then informed Mr. Watkins that he was going to be placed under arrest at this time. I instructed Mr. Watkins to place his hands behind his back and handcuffed double-locked Mr. Watkins. I searched the prisoner incident to arrest, searched the rear seat prior to and post transport. I then searched Mr. Watkins before placing him in my marked patrol vehicle (2302). Mr. Watkins was then seat belted in the backseat of my patrol vehicle, and I provided Ocean County Dispatch with my vehicles starting, and ending mileage. Upon arriving back at police headquarters I escorted Mr. Watkins inside, and secured my weapon before entering the processing room. Mr. Watkins was then secured to the bench via ankle cuff, and continuously monitored by myself, and Sgt. Covone. At this time I completed the Prisoner Property Sheet which is attached to this report. Mr. Watkins was then fingerprinted, and a mugshot was taken.

At this time officers entered the charges into New Jersey Courts. Officers then obtained a Preliminary Public Safety Assessment, and the Complaint Summons (1523S2024000078). Mr. Watkins was charged with Assault, and Criminal Mischief (2C:12-1c.(1) & 2C:17-3). Both charges were placed on a summons, and Mr. Watkins was provided with his defendant copy of the summons. Mr. Watkins was released from police custody with a court date of November 19, 2024 at 0930 hours.

After Mr. Watkins was released I contacted the victim Mr. Canka to inform him that Mr. Watkins was released from police custody, and provided him with the case # for this incident. It should be noted Mr. Canka emailed me picture of his foot injury which has been added to this report stating " Upon arrival of being home I noticed some swelling on my right foot starting to occur. I will be seeking medical attention. Can you please include that in tonight's report." At this time no further details to report.
