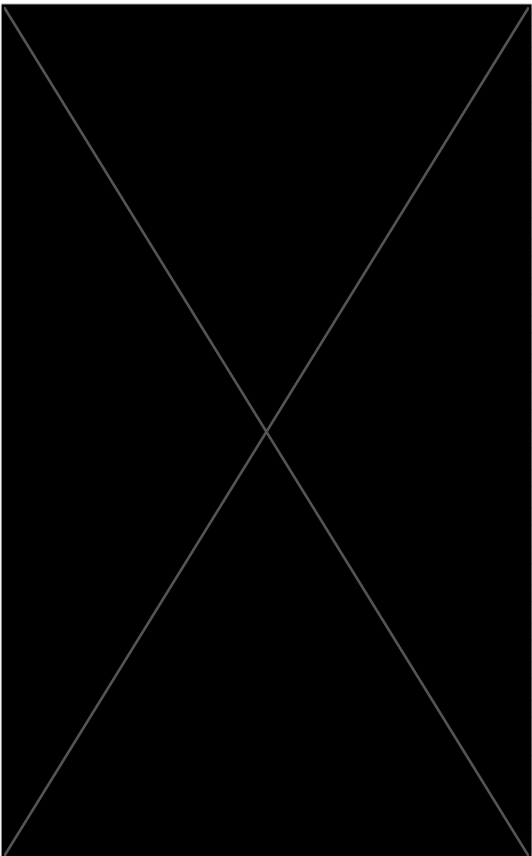

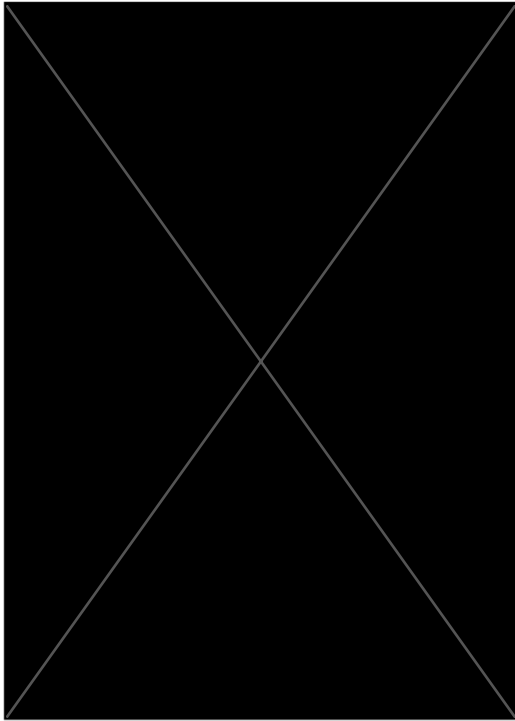

Narrative

Follow up investigation for case #23PM06175 from 05/28/2023. Chief Earl Meroney #257 brought this case to my attention and requested I look into it further.

I reviewed Officer Picinic's #289 report from 05/28/2023 and made contact with an on duty Assistant Prosecutor Madeline Buczynski from the Ocean County Prosecutors Office. I explained the circumstances from Officer Picinic's report as well as other complaints we have received from the New Egypt High School in regards to the unsecured weapons in [REDACTED] possession (reference case# 23PM06608). The New Egypt High School stated they were concerned since [REDACTED] has a "public dislike of the school". Upon further discussion with the Assistant Prosecutor, I applied for a Temporary Extreme Risk Protection Order (TERPO) against James Campos ([REDACTED] grandfather/guardian). Mr James Campos is [REDACTED] within 21 Brown Lane, New Egypt NJ 08533. The TERPO was approved by the Honorable Judge Robert Lapore and a search warrant for any and all firearms and ammunition located within 21 Brown Lane, New Egypt NJ 08533 was also granted by the Judge.

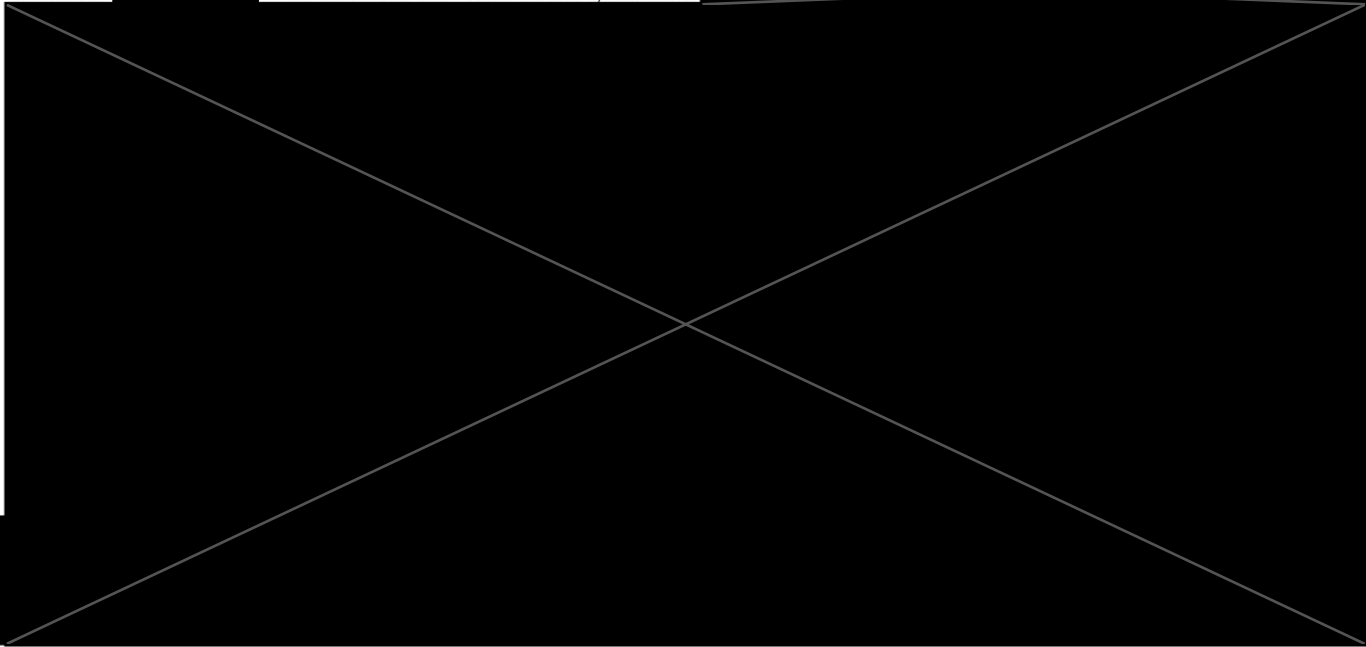

A Firearms search of Mr James Campos was conducted and revealed twelve (12) registered handguns in his name.

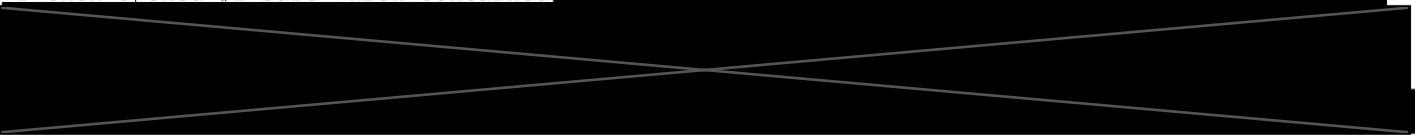
Sergeant Covone #260, Officer Zacco #291, and I (Sergeant Gary Schaal #266) responded to 21 Brown Lane, New Egypt NJ 08533 at approximately 2041 hours on Wednesday June 7th 2023 to serve a TERPO to James Campos, and execute a search warrant on the residence for any and all weapons and ammunition. I approached the front of the residence (21 Brown Lane) as Sergeant Covone was behind me, and Officer Zacco was behind him. Walking up the front porch to the residence I observed a window to a room inside the residence of which Officer Zacco covered. I continued to the right of the window and approached the front door. Sergeant Covone was positioned in between Officer Zacco and I. Officers were positioned on the front porch as I knocked on the front door. Initially I received no response, I then knocked again announcing myself as Sergeant Schaal Plumsted Police. At this time Officer Zacco reported that he witnessed through the bedroom window, [REDACTED] "grab a pistol" but then dropped it .

I was met at the front door by Terry Campos and her grandson [REDACTED] Terry Campos was refusing to allow Officers inside the residence as I was advising her we have a Search Warrant for the residence. Due to the exigent circumstances of Officer Zacco reporting that [REDACTED] had a handgun in his bedroom, I pushed open the front door to the residence and entered while explaining we had a search warrant. James Campos was still not present and accounted for, his wife (Terry) had stated he was in the bathroom. I continued to explain the TERPO to Terry and [REDACTED] and then Mr Campos came out from the bathroom at which time I advised him of the Search Warrant and TERPO.

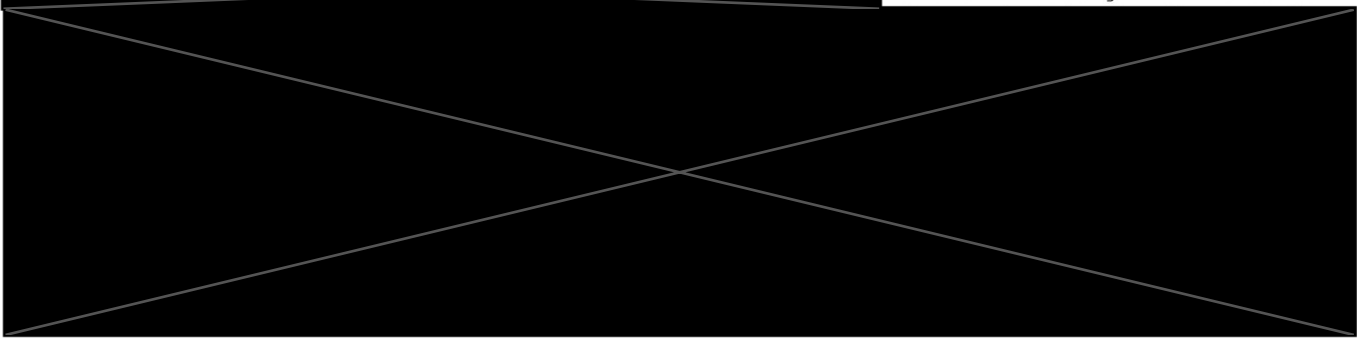
Sergeant Covone and Officer Zacco entered the bedroom which was believed to be the juveniles', [REDACTED] I confirmed with Mr Campos that the bedroom Officers were entering was indeed [REDACTED] A search of the room yielded [REDACTED]

All items taken into police custody from 21 Brown Lane New Egypt NJ 08533 was inventoried, photographed, and stored into evidence. Assistant Prosecutor Madeline Buczynski approved second degree charges of Endangering the Welfare of a Child on Mr Campos, Senior Assistant Prosecutor Anthony Pierro approved Juvenile charges on

On the above time and date, I, Ptl. Zacco, Sgt. Covone #260, and Sgt. Schaal #266 conducted a search warrant as per the granted TERPO at 21 Brown Ln for multiple weapons and ammunition for Safe Keeping until further notice.

At this time, I notified Sgt. Covone and Sgt. Schaal about what I observed for all officers safety.

At this time, Sgt. Coyone and I searched [REDACTED] room for weapons. the bedroom confirmed to be [REDACTED] as I previously have been at the residence and known to this Officer that the specific room was indeed [REDACTED] Sgt. Schaal confirmed with James Campos that the room we had entered was indeed [REDACTED] I witnessed the brown handgun that I observed [REDACTED] to pick [REDACTED]

The entire incident was captured via BWC.

[REDACTED] The residents were verbally abusive towards officers the entire time I was present. It should be noted that Ptl. Zacco advised us that that while we were knocking on the door he witnessed [REDACTED] load a round into a handgun.
