The Evesham Township Police Department Records Custodian received your OPRA request on **July 22, 2024**. The seven (7) business day deadline to respond to your request is **July 31, 2024**. A partial response and request for clarification was sent to you on **July 22, 2024**, with a due date of **July 31, 2024**. This response is being sent to you after the deadline period.

To date, we have not received a response to this request. Accordingly, we are closing your OPRA request as satisfied with our partial response.

If your request for access to a government record has been denied or unfilled within the seven (7) business days required by law, you have a right to challenge the decision by the Evesham Township Police Department to deny access. At your option, you may either institute a proceeding in the Superior Court of New Jersey or file a complaint with the Government Records Council (GRC) by completing the Denial of Access Complaint Form. You may contact the GRC by toll-free telephone at 866-850-0511, by mail at P.O. Box 819, Trenton, NJ, 08625, by e-mail at grc@dca.state.nj.us, or at their web site at www.state.nj.us/grc. The GRC can also answer other questions about the law. All questions regarding complaints filed in Superior Court should be directed to the Court Clerk in your County.

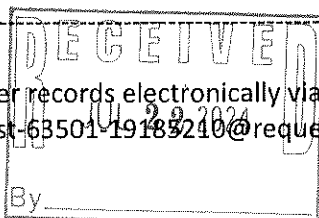
The second officer who responded to this call was a male (unidentified) who arrived at the scene in patrol car #2007 at approximately 09:35:00.
