I HAVE NOT been convicted of any indictable offense under the laws of New Jersey, any other state, or the United States.

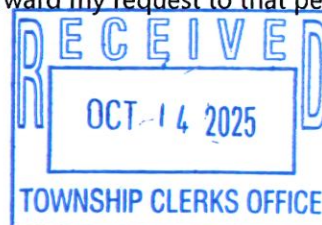
I WILL NOT use the requested government records for a commercial purpose.
