ON JUNE 19, 2025, AT APPROXIMATELY 1244 HOURS, THIS OFFICER, SERGEANT JEFFREY SELLMAYER OF THE JAMESBURG POLICE DEPARTMENT, WAS DISPATCHED TO JAMESBURG BOROUGH HALL/MUNICIPAL COURT FOR A REPORT OF AN UNWANTED PERSON. CALLER STATED A SUBJECT WAS FILMING INSIDE THE BUILDING. ON MY ARRIVAL, I ENTERED THE MAIN DOORS FOR BOROUGH HALL. I OBSERVED A SUBJECT KNOWN TO THIS OFFICER AS JENNIFER COOMBS SITTING AT A TABLE IN THE MAIN HALLWAY. I HAD RECENTLY INTERACTED WITH COOMBS AT HELMETTA BOROUGH WHERE SHE WAS FILMING THE PUBLIC AREAS OF HELMETTA BOROUGH HALL. I SPOKE WITH MUNICIPAL COURT ADMINISTRATOR CHRISTINE WARD WHO STATED SHE HAD A COURT ORDER ISSUED BY HON. MICHAEL TOTO THAT EXPRESSLY FORBIDS ANY AUDIO OR VISUAL RECORDING WITHIN SIX FEET OF THE MUNICIPAL COURT WINDOW WHEN BUSINESS WAS BEING CONDUCTED. THE COURT ORDER IS ATTACHED TO THE INCIDENT. I PRINTED A COPY OF THE ORDER AND PRESENTED SAME TO COOMBS. SHE WAS ADVISED SHE COULD CONTINUE HER BUSINESS AT BOROUGH HALL AND COULD FILM BUT SHE WAS ADVISED OF THE COURT ORDER. I PRESENTED COOMBS A COPY OF SAID ORDER AND I PHYSICALLY SHOWED HER WHERE SHE COULD NOT FILM. COOMBS WAS ADVISED THAT IF SHE DISOBEYED THE COURT ORDER SHE WOULD BE PLACED UNDER ARREST. I ALONG WITH DET. SGT JASON MULLER, ALSO OF THE JAMESBURG POLICE DEPARTMENT, STOOD BY WITH WARD IN HER OFFICE BRIEFLY TO ENSURE THERE WERE NO OTHER ISSUES. WE THEN CLEARED THE SCENE.
