On the above date and time I, Patrolman Hans was on walking patrol on the boardwalk in the area of Sheridan Avenue and the Boardwalk, I observed two male individuals engaged in loud, disorderly behavior. Both males were shouting profanities at an elevated volume, which could be clearly heard by numerous pedestrians in the immediate area. Their actions attracted significant attention from members of the public, causing several individuals to stop and observe the disturbance. At the time, the boardwalk was occupied by numerous civilians, including families with children.

Due to the disruptive nature of their conduct and the public attention it was generating, I approached the individuals and instructed them to cease their behavior. Both males continued yelling profanities despite my presence and verbal commands. Based on their actions, the decision was made to detain and escort both individuals off the boardwalk for the purpose of issuing Borough Ordinance Summonses for violation of Borough Code 154-11, Public Nuisance.

While detained and being escorted from the boardwalk, both males remained uncooperative and continued shouting profanities in a loud and irate manner. As officers attempted to identify the individuals and complete the summons process, the males repeatedly used offensive language and continued creating a disturbance. Their conduct continued to attract the attention of people walking by and nearby families, causing public inconvenience, annoyance, and alarm.

Despite being provided multiple opportunities to calm down and comply with lawful instructions, both males persisted in their disruptive behavior. Based on their continued behavior conduct in a public place and the disturbance their actions were causing to those in the area, both males were placed under arrest and charged with Disorderly Conduct 2C:33-2a(1).

The males were identified as Mr. Aiden Mchugh and Mr. William Jasolosky.

Search incident to arrest yielded negative results. Both males were transported to Seaside Heights Police Department for booking and processing and later released on a summons.
