Summary :

On this date and time, patrol units responded to location for request for officers for possible damage done to vehicles from the Bradley Beach Fireworks show on 4/3/2018. Upon arrival SO Poblete spoke with the caller identified as Beth Lees. Lees stated she discovered her vehicle appeared damaged from the fireworks the night before. Lees also stated she was concerned that the vehicles of several of her neighbors that were parked in front of 707 Ocean Ave, also appeared damaged. Upon further investigation it was discovered that all vehicles were not actually struck by any explosive or projectile materials and that the spots left on the involved vehicles were dried spots of soot caused by the rain and smoke from the fireworks. Further assessment of the Lees vehicles NJ/ D96JNK and NJ/NWF78X which she stated she had washed, yielded that the soot left on the vehicle was able to be removed with thorough wiping and there was no permanent damage to the paint or exterior of the car. At this time, the owners of the other involved vehicles agreed that the spots on their vehicles can be removed with thorough washing. Lees was advised of same and wishes to have the incident documented for report purposes.
