Narrative:

While on patrol in the Borough of Sea Girt, this officer was stopped at the intersection of New York Blvd. and Sea Girt Ave. This officer was on New York Blvd., west of SR71, facing east towards SR71. A vehicle was observed traveling south on SR71 at a high rate of speed. As the vehicle continued south on SR71, it quickly pulled up behind another vehicle also traveling south on the roadway. It should be noted that there was approx. four blocks between vehicles, but due to the high rate of speed, the distance was closed at a very fast pace. This officer observed the vehicle's brake lights illuminate once it caught up to the vehicle in front of it and began tailgating the vehicle, leaving approx. a half car length of less between vehicles. The vehicle in violation continued tailgating the vehicle in front of it as it swerved from side to side of the south bond lane touching the center line and fog line of the lane several times. At this time, this officer was now traveling behind. This officer activated the patrol vehicle's front/ moving/ same lane radar and received a reading of 40 MPH. The posted speed limit is 35 MPH.

A motor vehicle stop was conducted for speeding, tailgating, and failure to maintain lane. Once stopped this officer approached the driver's window of the vehicle and observed a female operator. This officer requested the driver's license, registration, and insurance card. The driver handed over an insurance card and advised she did not have her driver's license on her person. The driver appeared excited and jumpy while speaking with her. This officer asked the driver to exit the vehicle to which she complied. The driver's name and date of birth was obtained and relayed to dispatch to check for validity and warrants. During this time, 44558 arrived on location as backup. While this officer was awaiting a response from dispatch, 44558 spoke with the driver. This officer observed the female acting nervous as she was fidgety and moving around rapidly. 44558 requested consent to search the female because of this nervous behavior. Consent was given by the female, now identified as Amy

Hitchens. Dispatch advised that Hitchens had a suspended license and an active warrant for \$433.00 out of South Toms River.

44558 explained the consent to search form to Hitchens, to which she initialed each line and gave consent. A search of the vehicle yielded negative results for any illegal contraband.

Hitchens was allowed to smoke a cigarette and then was placed under arrest. She was handcuffed using the double lock mechanism and placed in the rear seat of patrol vehicle 4426. This officer contacted a matron via the OIC phone.

Once at police headquarters, South Toms River PD contacted this agency and advised they would ROR Hitchens. They faxed over the bail recognizance form, which was signed by Hitchens.

This officer along with the matron transported Hitchens back to the vehicle where a valid driver responded to take the vehicle.

Hitchens was issued summonses for tailgating, failure to maintain lane, and driving while suspended. She was issued warnings for failure to exhibit a driver's license, speeding, and failure to change address. She was issued a new court date for South Toms River for October 22, 2018 and a court date for the summonses for November 14, 2018.
