On November 16th, 2018 at approximately 1937 hours, I, Ptl. Bodner, was dispatched to 87 Belaire Court to assist Aberdeen Police department.

Upon arrival, I spoke with Aberdeen PD Officer Ptl. Marone who advised that they had received a call for an assault that occurred in our town. Ptl. Marone told me that Curtis Friday Jr. was assaulted in his living room at 121 Ravine Dr. possibly apartment #48 and was dropped by his roommate, Tracy Morgan, at Belaire Court following the assault. I advised Ptl. Marone that location would most likely be the Treehaven II apartments at 120 Ravine Dr not 121. Ptl. Budelmann spoke with Friday who was not cooperating with the investigation by not initially providing his name, location, or name of his roommate. Friday eventually advised that he was assaulted in his living room possibly by a white male with a medium build. Friday was unsure of how he came to Belaire Court and continued to change his story slightly while talking with him. Bayshore EMS was on scene and transported Friday to the hospital for treatment of his injuries.

Ptl. Marone and I went to Treehaven II apartment #48 to speak with Tracy Morgan. We initially went to 48A and spoke with the resident there who told us that Morgan may live in the upstairs apartment. We then went to 48B to speak with the residents. We found that no one was home at the time. While on scene we spoke with the upstairs neighbor who advised a family lived in the apartment and not the subjects we were looking for. The neighbor was unfamiliar with either Friday or Morgan and did not hear any type of disturbance tonight at the apartment.

Sgt. O'Boyle notified Capt. Hourihan and DSgt. Sakowski notifying him of the assault. DSgt. Sakowski advised that Det. Lovallo would be responding to the hospital to speak with Friday. I advised Det. Lovallo of my findings at the apartment.

I continued to ask Friday questions to try and determine where the assault took place. Friday repeatedly change his story on what took place, who assaulted him and where it took place. At first he told me that it was a black male who assaulted him and then he told me that it was a white male that assaulted him. He went back and forth several times on the description of who assaulted him. I then was trying to determine where the assault took place to determine what agency should be investigating this incident. He first told me that it took place in his apartment, 120 Ravine Dr Apt 48A Matawan, N.J. 07747. I spoke with Ptl Bodner who told me that he responded to that address after Friday was transported to the hospital and found that a different family lives there. Friday then told me that it did not occur there but would not tell me where it occurred. I asked Friday if he wanted to cooperate and wanted the assistance and help of the Police and he told me no, and to leave it alone. I continued to speak with Friday in an attempt to gather the information needed to help Friday and to conduct my investigation but was unsuccessful. I told Friday that I was going to leave and that he could contact me anytime to follow up or that I would try to get in touch with him on Monday to see if he would cooperate.
