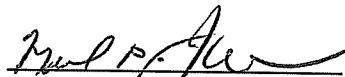

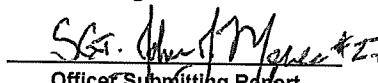
Our department has authorized all firearms and ammunition logged on these reports.
