78. Narrative This department received information that was posted on social media that Atilis Gym was planning on opening their gym located at 363 W. Browning Rd in violation of the governor's order and there were numerous people and groups commenting that they would be coming to that location to show their support for the business. This department prepared for a large crowd of gym supporters to come on the date the owner's stated by social media that they were opening on 5-18-2020. In our discussions on how to prepare for possible large crowds, several other police departments and the prosecutors office were contacted to have officers available if needed. We planned to have a Command Post set up at Annunciation School, and officers were stationed at several sections of the parking lot close to the entrance off of W. Browning Rd by the strip stores to prevent any vehicles entering and possibly striking protesters. It was discussed and agreed upon that we would attempt to not charge anyone and at the end of the day serve charges to the owners on a Special Complaint for violating the governors order if they opened, this was also agreed to by the Camden County Prosecutors Office. Chief Walsh was in contact with the Prosecutors Office and the Bellmawr Borough Attorney who had attempted to contact Atilis representatives and advise them of the violation and possible charges if they opened the gym in violation of the governors order, but they were unable to reach them. On Monday, 5-18-2020, at approx. 0630 officers began to arrive at the location and observed news vans, and large groups of people standing in the parking lot primarily in front of the business. There was a female with a speaker, later found to be Stephanie Hazelton who was inciting the crowd. We were later informed by the Camden County Prosecutors Office that Hazelton, who goes by the name of Ayla Wolf was the organizer of the event. Standing with

her were the owners of Atilis Gym.

The gym was allowing people in and out of the gym to exercise and members leaving during the day that had been in the gym had advised that they had done their exercise when leaving to the crowd outside while carrying their gym bags in hand.

This department was advised by C.C.P.O. that we make in person notification to the owners of Atilis Gym that they were in violation of the governors order. Capt. Parker walked up to the crowd with the undersigned and after getting everyone to quiet down and had their attention he advised them that they were in violation of the Governors Executive Order and they could be charged. We then walked away and the crowd cheered because no one was arrested and began to thank officers.

Not long after this I was advised that the Camden County Prosecutors Office was requesting to charge both owners now with violating the governors executive order on a special complaint and serve them immediately, then continue to announce to the crowd throughout the day that they are in violation of the governors order and are being directed to immediately disperse, and if they did not disperse they could be charged.

I wrote up the charges for both owners and as I did so Hazelton who was on a bullhorn began to shout out to protestors that the police would shortly be arriving to charge the owners. I served both owners while the large crowd and media surrounded us screaming obscenities and acted highly agitated

No other charges were made throughout the day and in the late afternoon most of the protesters and news vans left.

On Tuesday, 5-19-2020, patrols responded early in the morning to again observe a large crowd and news vans in the lot with protestors shouting. Patrols stood by on location and monitored for problems after observing that the gym was open for business with people coming in and out believed to be exercising in the gym because of the length of time they were inside and carrying gym bags, water bottles and weight lifting belts.

I was informed that the C.C.P.O. wanted me to charge and serve the owners at this time for violating the Governors Order. After writing out the Special Complaints. I approached the door with officers and both owners came out of the gym. They were handed their summonses and I advised the crowd again with a statement provided to me by superiors that they were in violation of the governors order, and they needed to immediately and peaceably disperse if they did not disperse they could be charged, and that they could protest from their vehicles.

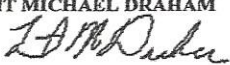
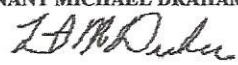
The owners were cooperative with police and spoke with demonstrators several times during the protest that they should cooperate with police and their demonstration was against the governor. Some of the demonstrators went to their vehicles, but a lot remained to protest. They had to be told several times not to gather in groups of more than ten and to stay out of the roadway.

During the course of the day several people went inside the gym with gym bags and they were inside for an hour or longer and were then observed leaving.

During the time the business had all windows covered from the inside where you could not see inside, and had bouncers at the door not letting anyone inside but employees or members and would quickly shut the doors so inside could not be viewed.

The gym also sold supplements which made it difficult to know what people were going inside for.

The undersigned was advised that we needed to charge members with violating the governors order per the Camden County Prosecutors Office. We explained that it was difficult because we cannot not see what they are doing inside the business. We were told that we are justified if they are in there for a length of time and appeared to have used the equipment, like carrying a gym bag, ect. I also asked if they refuse to provide their information and it being the governor's order can they be charged with obstruction which I was informed they could. We observed a few members leaving with gym bags who were in the gym for an hour or longer and were stopped and issued a Special Complaint for violating the Governors Order. One subject, Matthew A Baklycki was stopped coming out of the gym and advised he was going to be charged and to provide his personal information but he refused. I explained to him that he was

required to provide it and he would receive a court date and he still refused. He was placed under arrest and transported to Bellmawr Police where he then provided his information, was charged with violating the governors order and obstruction and released. When Baklycki was placed under arrest a large crowd of protestors and media gathered around yelling at officers.

The undersigned spoke with CCPO Nevan Soumilis who asked if the female (Stephanie Hazelton) was still on the speaker shouting to the crowd, which I explained she was. She said that we needed to charge her because she organized the protestors to violate the governors order on both days.

Some of the crowd continued to assemble in front of the business in crowds more the 10 standing tightly together while Hazelton was on the megaphone inciting the crowd. The crowd had been told to disperse immediately several times and to protest in their vehicles but they remained. I instructed Ptl. Deberardinis to call Hazelton over get her information and charge for violating the governors order.

Officers had followed several people out of the gym toward their vehicles who appeared to have used the equipment and asked if they used the equipment, which if they acknowledged they did the officers served them a summons for the violation. While doing this media and protestors would run to and surround officers talking to subjects who had worked out, and it became too dangerous.

On Wednesday 5-20-2020, the gym again opened and people were going inside with gear. After they were inside for a while they would leave as if they had used the equipment inside. The owners were again charged on Special Complaints with charges requested by the Camden County Prosecutors Office. These charges were mailed to both subjects. There was also a crowd of gym supporters in front of the gym.

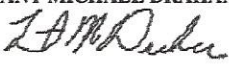
Officers were requested by the Camden County Prosecutors Office to stop vehicles occupied by subjects who were believed to be using the equipment in the gym after leaving the parking area and issue the subjects complaints for same.

In the afternoon on Tuesday 5-19-2020, and Wednesday, our detectives sat in the parking lot in an unmarked vehicle and monitored people coming and going to the gym. They relayed information to officers from what they observed. (see sup report)

On Wednesday night the owners of Atilis Gym put out on social media that they had sewage backing up from a drain in the building and would be closed on Thursday 5-21-2020. I called our public works department on 5-21-2020 and I was informed that the sewer dept. did go to the building around 6:00pm on Wednesday and found that someone clogged the sewage from the inside of the building with a roll of toilet paper .

On Friday 5-22-2020. The gym opened again, I observed people coming in and out of the gym. The group of supporters in front of the gym was not as large as earlier in the week and we kept officers away unless called for a problem so not to incite the crowd with our presence, which seemed to be what they wanted with the media present. The gym owners were charged on a summons with violating the governors order in addition to two counts of maintaining a nuisance and same was mailed to their residence.

Later Friday night the Camden County Sheriff Dept. changed the locks on the building advising the owners that they were enforcing a Civil Order.
