On 10/08/2023 at 2135, I Ptl. K.Wardell #18159 was dispatched to 307 Algonquin Trl fro a report of harassment. A short time later I arrived.

Upon my arrival, I made contact with Wendy Mitchell who reported that after the police left her neighbor's house for a noise complaint he began screaming out his side door towards her house. Mitchell stated that her neighbor Christopher Forman was screaming that he was going to get her this weekend and that she needs to cut her lawn or she is going to get a violation from the town. Mitchell stated that there has been an on going issue with the neighbor. Mitchell reported that all through out the night, Forman plays loud music and the bass from his DJ equipment shakes her house. Mitchell reported that some nights is so bad that she has to sleep on the couch. Mitchell stated that she has attempted to contact Forman regarding the noise but he just turns it louder.

I advised Mitchell of her right to sign a citizens complaint for the noise or the harassment in which she stated that she did not want to at this time. I advised her of the complaint process and how to file a citizens complaint.

Earlier in the night when I responded to Forman's residence for the noise complaint I advised him of the township ordinance. Forman stated that he was not using his DJ equipment and had recently come home, in which his music was playing from his car speakers. Forman became highly irate and blamed the neighbor for the complaint. I advised him that it was an anonymous caller that called in the complaint. End of report.
