Response to Common Law Request

The common law right to access public records depends on three requirements: (1) the records must be common law public documents, *Nero v. Hyland*, 76 N.J. 213, 222 (1978); (2) the person seeking access must “establish an interest in the subject matter of the material,” *South Jersey Publishing Co. v. New Jersey Expressway Auth.*, 124 N.J. 478, 487 (1991); and (3) the citizen’s right to access “must be balanced against the State’s interest in preventing disclosure.” *Loigman v. Kimmelman*, 102 N.J. 98 (1986).

After consultation with the Township Solicitor, we have determined that you have failed to establish a proper interest in the requested records. Your request is therefore denied.

Response to OPRA Request

Copies of the identified CAD Activity Detail Reports are enclosed. Please note that, after consultation with the Township Solicitor, portions of these records have been redacted as follows:

Privacy/Personal Information. Portions of the identified record(s) containing information for which identified persons have a reasonable expectation of privacy have been redacted. N.J.S.A. 47:1A-1; Executive Order No. 21 (McGreevey 2002); *Paff v.*

Bergen County Prosecutor's Office*, 233 N.J. 330 (2018); *In the Matter of the New Jersey State Fireman's Association*, 230 N.J. 258 (2017); *Burnett v. County of Bergen*, 198 N.J. 408 (2009); *North Jersey Media Group v. Township of Nutley*, slip op., Docket No. A-3483-14T3 (App. Div. September 30, 2016); *Nelson v. N.J. Protected Health Information. The identified record(s) or portions thereof are not subject to disclosure because they contain protected health information exempt from disclosure pursuant to the Privacy Rule implemented pursuant to the Health Insurance Portability and Accountability Act of 1996 and Executive Order No. 26, paragraph 4.b.1 (McGreevey 2002) (exempting from disclosure "information relating to medical, psychiatric or psychological history, diagnosis, treatment or evaluation").

In addition, after consultation with the Township Solicitor, your request for the identified Incident Reports and portions of the identified CAD Activity Detail Reports is denied for the following reason:

Criminal Investigatory Exemption. The identified records or portions thereof constitute criminal investigatory records which are not required by law to be made, maintained or kept on file, and which pertain to a criminal investigation. Such records are therefore exempt from disclosure pursuant to the criminal investigatory records exception of OPRA, N.J.S.A. 47:1A-1.1; *Paff v. Ocean County Prosecutor's Office*, 235 N.J. 1 (2018); *North Jersey Media Group, Inc. v. Township of Lyndhurst*, 229 N.J. 541 (2017); *Schulz v. N.J. State Police*, Complaint No. 2014-390 (GRC 2015).

If your request for access to a government record has been denied or unfilled within the seven (7) business days required by law, you have a right to challenge the decision by the Township of West Deptford Clerk's office to deny access. At your option, you may either institute a proceeding in the Superior Court of New Jersey or file a complaint with the Government Records Council (GRC) by completing the Denial of Access Complaint Form. You may contact the GRC by toll-free telephone at 866-850-0511, by mail at P.O. Box 819, Trenton, NJ, 08625, by e-mail at grc@dca.state.nj.us, or at their web site at www.state.nj.us/grc. The GRC can also answer other questions about the law. All questions regarding complaints filed in Superior Court should be directed to the Court Clerk in your County.
