Both parties were advised this is a civil matter.

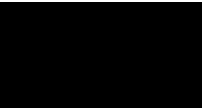
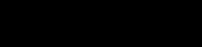
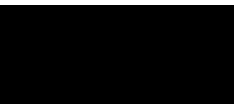
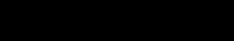
