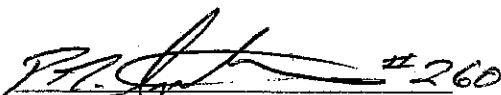

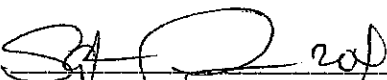

ON THE ABOVE DATE AND TIME THIS OFFICER WAS DISPATCHED TO 321 2ND ST. FOR A VANDALISM TO A WINDOW. UPON ARRIVAL I WAS MET BY THE VICTIM EDWARD C. FAKTOR. MR. FAKTOR STATED THAT HE LEFT THE OFFICE LAST NIGHT ON 07/25/12 AT APPROXIMATELY 2000HRS AND RETURNED ON THE MORNING OF 07/26/12 AT APPROXIMATELY 0830HRS.
